

RESOLUTION No. 08 – 29

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING A CHANGE ORDER TO THE AGREEMENT WITH METRO EXPRESS INC. IN AN AMOUNT NOT TO EXCEED \$108,896.00 FOR THE PROVISION OF ADDITIONAL CONSTRUCTION OF STORMWATER IMPROVEMENTS ALONG N.W. 102ND AVENUE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral has implemented a Stormwater Master Plan to meet the stormwater needs of its residents and businesses; and

WHEREAS; the City of Doral has an existing agreement with Metro Express Inc. (MEI) to perform Construction of Stormwater Improvements; and

WHEREAS, although Miami-Dade County deleted the stormwater improvements project along N.W. 102nd Avenue between theoretical N.W. 53rd Street and N.W. 56th Terrace, the City has decided to move forward with the construction of the improvements along N.W. 102nd Avenue in keeping with the City of Doral Stormwater Master Plan; and

WHEREAS, Staff respectfully requests that Council approve a changer order to the agreement with MEI in an amount not to exceed \$108,896.00 for the provision of additional construction of stormwater improvements along N.W. 102nd Avenue.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby approves a changer order to the agreement with MEI in an amount not to exceed \$108,896.00 for the provision of additional construction of stormwater improvements along N.W. 102nd Avenue.

Section 2. This Resolution shall take effect immediately upon adoption.
