

**RESOLUTION No. 18-181**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDED INVITATION TO BID #2018-21 FOR “MOTORCYCLE LEASING SERVICES AND ACCESSORIES” TO JS FLORIDA MOTORSPORT LLC DBA ALLIGATOR ALLEY HARLEY DAVIDSON; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH JS FLORIDA MOTORSPORT LLC DBA ALLIGATOR ALLEY HARLEY DAVIDSON FOR THE PROVISION OF MOTORCYCLE LEASING SERVICES AND ACCESSORIES FOR THE POLICE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$343,126.80 AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the “City”) Police Department seeks to lease motorcycles; and

**WHEREAS**, on July 27, 2018, the City issued Invitation to Bid 2018-21, Motorcycle Leasing Services and Accessories for the Police Department, (the “ITB”), and as a result of the advertisement on the City’s Website and Demandstar, two (2) submittals were received and opened on August 23, 2018, with both firms meeting the required criteria; and

**WHEREAS**, JS Florida Motorsport LLC dba Alligator Alley Harley Davidson was found to be the lowest most responsible and responsive bidder; and

**WHEREAS**, staff has recommended the City award the ITB to JS Florida Motorsport LLC dba Alligator Alley Harley Davidson and authorize the manager to negotiate and enter into an agreement with JS Florida Motorsport LLC dba Alligator Alley Harley Davidson for the motorcycle leasing services and accessories, in an amount not to exceed \$343,126.80 for a 36 month period with a second three (3) year renewal.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Award.** The ITB, for the provision of motorcycle leasing services and accessories for the police department, is hereby awarded to JS Florida Motorsport dba Alligator Alley Harley Davidson pursuant to the terms specified herein. This award does not confer any contractual rights on JS Florida Motorsport dba Alligator Alley Harley Davidson.

**Section 3. Authorization.** The City Manager is authorized to negotiate and enter into agreement with JS Florida Motorsport dba Alligator Alley Harley Davidson, subject to approval by the City Attorney as to form and legal sufficiency, to provide the Police Department with their motorcycle leasing services and accessories, in an amount not to exceed \$343,126.80 for a 36 month period with a second three (3) year renewal, and on such other terms and conditions as may be in the best interest of the City. The City Manager is further authorized to expend budgeted funds from Rental and Leases account 001.60005.500440 on behalf of the City with respect to the agreement approved herein.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilmember Mariaca who moved its adoption. The motion was seconded by Councilmember Cabrera and upon being put to a vote, the vote was as follows:
