City Manager's Office

Acting City Manager along with Deputy City Manager, City Clerk Diaz and, City Attorney Figueredo held weekly Staff Meeting with Department Directors. The following items were discussed:

Nine resignations were received in the past week.

PUBLIC WORKS

The EPA audit went very well. Doral was ranked amongst the highest in the County.

Elevator for the police department was received last week and its installation is ongoing.

ECONOMIC DEVELOPMENT

Coordinating the Sister City signing ceremony.

The Business Outreach Coordinator began working this week.

Meeting with USA Today to discuss a special feature piece they are doing on Doral.

PLANNING & ZONING

Follow up meeting with the developer of Midtown II.
