

RESOLUTION NO. 09 – 32

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO A MUNICIPAL LEASE AGREEMENT FOR THE PROVISION OF A DORAL TROLLEY REPLACEMENT IN AN AMOUNT NOT TO EXCEED \$4,400.00 PER MONTH FOR A THREE (3)-YEAR TERM; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The City of Doral Public Works Department is replacing the existing gas engine trolley with a diesel engine trolley capable of operating with biodiesel fuel; and

WHEREAS, after researching alternative cost-saving procurement options, Staff concluded that a municipal lease is in the best interest of the City; and

WHEREAS, with the use of a municipal lease, there will be an initial \$15,000 cost but the monthly payment will drop to approximately \$4,400.00 saving the City more than \$1,000 per month over the previously approved procurement method; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into a municipal lease agreement for the provision of a Doral trolley replacement in an amount not to exceed \$4,400.00 per month for a three (3)-Year term.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council hereby authorizes the City Manager to negotiate and enter into a municipal lease agreement for the provision of a Doral trolley replacement in an amount not to exceed \$4,400.00 per month for a three (3)-Year term.

Section 2. This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilman Van Name who moved its adoption. The motion was seconded by Vice Mayor DiPietro and upon being put to a vote, the vote was as follows:
