

RESOLUTION No. 13-129

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING AN OUTDOOR EVENT PERMIT FOR MY ECUADOR ADVERTISING, INC., TO HOST THE “ECUADOR GET TOGETHER” EVENT AT J.C. BERMUDEZ PARK ON SATURDAY, NOVEMBER 23, 2013 FROM 9:00 AM TO 6:00 PM ; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, My Ecuador Advertising, Inc. (“Applicant”) seeks approval from the City of Doral for an Outdoor Event Permit; and

WHEREAS, Staff respectfully recommends that Council approve the proposed Outdoor Event Permit for the Applicant to host the “Ecuador Get Together” event on Saturday, November from 9:00 am to 6:00 pm at J.C. Bermudez Park located at 3000 NW 87th Avenue

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The outdoor event permit for the “Ecuador Get Together” event is hereby approved subject to the following conditions:

- i. All necessary rentals, clean-up and staff fees, pursuant to the fee schedule attached, must be furnished to the Parks and Recreation Department prior to the event (Please refer to the attached fee schedule).
- ii. Construction plans for tents and any outdoor structural facility must be submitted to the Building Department for approval and final inspection prior to the event.


- iii. An agreement with the City of Doral Police must be entered into prior to the event for the provision of off-duty police officers security detail (Please refer to the attached action plan fee schedule).
- iv. Event hours of Operation limited from 9:00 am to 6:00 pm.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilmember Rodriguez Aguilera who moved its adoption. The motion was seconded by Councilmember Rodriguez and upon being put to a vote, the vote was as follows:


