WHEREAS, Matthew Fillioe on behalf of Liberation Event Management, LLC (the "Applicant") seeks approval from the City of Doral for a Special Event Permit to host the "Good Libations" event; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. **Approval**. The special event permit for the "Good Libations" is hereby approved subject to the following conditions:

- 1. Applicant shall comply with comments made by the City of Doral Police and Parks Departments and pay all applicable fees.
- 2. Applicant shall obtain all required permits and licenses.
- 3. Applicant shall be required to have all inspections and approvals prior to the event date.

4. Applicant shall provide to the City of Doral with an acceptable certificate of insurance four weeks prior to the event date.
