A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO WORK WITH DIVINE SAVIOR ACADEMY TO HOST A GOVERNMENT CENTER TOUR ON NOVEMBER 14, 2024, INTENDED TO INFORM STUDENTS ON HOW LOCAL GOVERNMENT WORKS; PROVIDING FOR A WAIVER OF STAFF COSTS IN THE AMOUNT OF \$120.00; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Divine Savior Academy is a private Christian academy, registered as a non-profit organization, located in the City of Doral ("City") and provides the community with preschool, elementary, middle school, and high school education for PreK3-12th grade, including a special needs program; and

WHEREAS, Divine Savior Academy is proposing to host tour on November 14, 2024, from 9:00am to 11:00am at the Doral Government Center; and

WHEREAS, according to Divine Savior Academy, the tour benefits the City as it educates young students and promotes pride in their city, knowledge, and civic duty; and

WHEREAS, in addition to requesting use of the City's facility, Divine Savior Academy, is further requesting that the City waive the \$120.00 in staff costs.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.
