

RESOLUTION NO. 11- 38

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO TWO (2) AGREEMENTS WITH FLORIDA POWER AND LIGHT FOR THE PROVISION OF DEVELOPING THE SEPARATE N.W. 50TH STREET PARK AND BIKEWAY SEGMENTS FROM N.W. 117TH AVENUE TO N.W. 112TH AVENUE ALONG N.W. 50TH STREET; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City is currently working on two highly anticipated projects: the development of the N.W. 50th Street Park and; segments of the bikeway path along N.W. 50th Street; and

WHEREAS, portions of every parcel of land for these projects fall under the Florida Power and Light (FPL) utility easements; and

WHEREAS, in order to develop the N.W. 50th Street Park and Bikeway segments, the City is required to sign an agreement with FPL for use of the land within their easement; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into two (2) agreements with FPL for the provision of developing the separate N.W. 50th Street Park and Bikeway segments from N.W. 117th Avenue to N.W. 112th Avenue along N.W. 50th Street.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into two (2) agreements with FPL for the provision of developing the separate N.W. 50th Street Park and Bikeway segments from N.W. 117th Avenue to N.W. 112th Avenue along N.W. 50th Street.

Section 2. This Resolution shall become effective immediately upon adoption.

The foregoing Resolution was offered by Councilman Boria, who moved its adoption. The motion was seconded by Councilman Cabrera and upon being put to a vote, the vote was as follows:


