

RESOLUTION No. 16-11

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF EIGHTEEN POLICE VEHICLES AND DECALING BY L.S. SIGNS, IN AN AMOUNT NOT TO EXCEED \$621,793.26, VIA THE AGREEMENT WITH THE FLEET SHERIFF'S ASSOCIATION AND DON REID FORD; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") seeks to purchase 18 police interceptor vehicles (the "Vehicles") from Don Reid Ford for the Police Department, as part of the City's regular fleet replacement schedule; and

WHEREAS, staff has reviewed the Agreement with the Don Reid Ford and the Fleet Sheriff's Association, which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V of the City Code, and found the terms to be advantageous to the City; and

WHEREAS, staff has recommended that the City Council authorize the City Manager to negotiate and enter into an agreement with Don Reid Ford for the purchase of the 18 Vehicles and decaling by L.S. Signs, in an amount not to exceed \$621,793.26 via

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part of this reference.

Section 2. Approval. Pursuant to section 2-322 of the City Code, the procurement of the Vehicles and decaling by L.S. Signs, in an amount not to exceed \$621,793.26, via Don Reid Ford and the Fleet Sheriff's Association which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V of the City Code of Ordinance, is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Vehicles under the Fleet Sheriff's Association Agreement with Don Reid, and to expend funds in furtherance hereof, in amounts not to exceed \$621,793.26.


Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.
