

**RESOLUTION NO. 08- 31**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO APPLY FOR THE BYRNE GRANT AVAILABLE THROUGH THE MIAMI-DADE DEPARTMENT OF HUMAN SERVICES; TO APPLY FOR, AMEND, RECEIVE, EXPEND \$5,000.00 AND EXECUTE AGREEMENTS WITH THE PURPOSE OF CREATING A SCHOOL RESOURCE OFFICER PROGRAM; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City desires to accomplish the purpose outlined in the accompanying memorandum a copy of which is incorporated herein by reference (EXHIBIT "A").

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA**, that this Council authorizes the City Manager to apply to the Byrne Grant for funds in the approximate amount of \$5,000.00; to execute such contracts and agreements as are required by this governmental body following the approval of the City Council; to execute such other contracts as will serve to further the purposes described in the funding request, following the approval of the City Council; to expend any and all monies received for that purpose described in the funding request; to receive and expend any additional funds that may become available during the term of the grant; to file and execute necessary amendments to the application for and on behalf of the City of Doral, Florida; and to exercise amendment, modification, renewal, cancellation and termination clauses of any contract and agreements on behalf of the City of Doral, Florida.

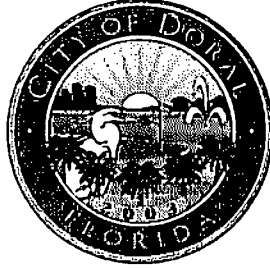

### **Background**

The Police Department is hereby requesting authorization to present a resolution on behalf of Miami-Dade County overseer of the Byrne Grant facilitated by the State of Florida every year. The City of Doral benefited last year from such grant and it is once again the benefactor of said grant awarded to the Doral Police Department in the amount of \$5,000.00.

This program incorporates the Rad Kids initiative a national awareness campaign which prepares and trains young boys and girls in self defense and public awareness when approached by strangers or while frequenting public places. This will be our third year of offering this training and its cost have been budgeted for.

### **Recommendation**

That the City of Doral Police Department once again is allowed to benefit from said grant. The protocol to be followed is once again a resolution approved by City Council as done in previous years. Ms. Barbara Herrera, City Clerk is in possession of last year's resolution and will formulate the necessary changes upon your approval for the next scheduled Council Meeting.
