

RESOLUTION No. 21-236

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, APPROVING THE PURCHASE OF 12 HARLEY-DAVIDSON MOTORCYCLES FROM ALLIGATOR ALLEY HARLEY-DAVIDSON IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS VIA THE FLORIDA SHERIFFS ASSOCIATION CONTRACT No. FSA20-VEL28.0; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Police Department for the City of Doral (the "City") seeks to purchase 12- Harley-Davidson motorcycles via the Florida Sheriffs Association Contract FSA20-VEL28.0; and

WHEREAS, by purchasing the motorcycles, the Police Department will be able to extend the life of the motorcycles beyond the period currently utilized in a lease. By that time the motorcycles are 5 years old with an average of 25,000 miles on them and would still have a trade-in value towards new motorcycles; and

WHEREAS, section 2-322 of the City Code of Ordinances authorizes the City to purchase goods and services via the contracts of other governmental entities, provided that such contracts have been achieved in a competitive manner similar to those established in the City Code; and

WHEREAS, Staff recommends that the City Council authorize the City Manager to negotiate and enter into an agreement with Alligator Alley Harley-Davidson as primary vendor via the Florida Sheriffs Association Contract FSA20-VEL28.0 for the purchase of 12 Harley-Davidson motorcycles from in an amount not to exceed budgeted funds, which was competitively entered into in a matter similar to

that set forth in Chapter 2, Article V of the City Code; and

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Pursuant to Section 2-322, the purchase 12 Harley-Davidson motorcycles from Alligator Alley Harley-Davidson via the Florida Sheriffs Association Contract FSA20-VEL28.0 in an amount not to exceed budgeted funds is hereby approved. This purchase is funded from the Capital Outlay-Vehicles #001.60005.500641.

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the motorcycles under the Florida Sheriffs Association contract to expend funds in furtherance thereof in amounts not to exceed budgeted funds.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Mariaca who moved its adoption. The motion was seconded by Councilmember Cabral and upon being put to a vote, the vote was as follows:


