

**RESOLUTION No. 11-72**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ACCEPTING A SUB-GRANT FOR THE BUFFER ZONE PROTECTION PROGRAM (BZPP) – FEDERAL RESERVE BANK OF ATLANTA – MIAMI BRANCH AWARDED TO THE CITY OF DORAL IN THE AMOUNT OF \$199,000.00; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Federal Reserve Bank of Atlanta – Miami Branch is a critical infrastructure that is located in the City of Doral; and

**WHEREAS**, the goal of the Buffer Zone Protection Program (BZPP) is to create a barrier of protection and digitally acquire visual data of the accessibility to the Federal Reserve Bank of Atlanta – Miami Branch; and

**WHEREAS**, the City of Doral has been awarded a BZPP – Federal Reserve Bank of Atlanta – Miami Branch sub-grant in the amount of \$199,000.00 to protect, secure and reduce the vulnerability of identified critical infrastructure and key resource sites; and

**WHEREAS**, Staff respectfully requests that the City Council accept the sub-grant awarded to the City of Doral for the BZPP – Federal Reserve Bank of Atlanta- Miami Branch in the amount of \$199,000.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:**

**Section 1.** The City Council hereby accepts the sub-grant awarded to the City of Doral for the BZPP – Federal Reserve Bank of Atlanta- Miami Branch in the amount of \$199,000.00.
