A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING AND APPROVING ROAD CLOSURES AT NW 74TH AND 75TH TERRACE AT NW 112TH AVENUE AND AT NW 77th LANE AT NW 114th AVENUE AND THE INSTALLATION OF EXIT ONLY ELECTRONIC GATES AT NW 75th LANE AT NW 112th AND THE INSTALLATION OF AN ENTRANCE FEATURE AT NW 75TH LANE AND NW 114TH WITH AN ENTRANCE/EXIT ELECTRONIC GATE THAT ALLOWS/PERMITS FOR PUBLIC ACCESS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Polynesian at Island at Doral Neighborhood Association, Inc., ("Applicant") has requested approval for road closures at NW 74th and 75th Terrace at NW 112 Avenue, the installation of exit only electronic gates at NW 77th Lane at NW 114th and NW 75th Lane at NW 112th, and the installation of an entrance feature at NW 75th Lane and NW 114th with an electronic gate; and

WHEREAS, on September 9, 2009, the City Council held a public hearing and after careful review and deliberation, including a review of staff's recommendation, determined that it is in the best interests of the citizens of the City of Doral to approve the road closures and entrance gates, subject to conditions;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF DORAL, FLORIDA THAT:

Section 1. The City Council of the City of Doral hereby approves Applicant's request to close NW 74th and 75th Terrace at NW 112 Avenue and NW 77th lane at 114th and to make NW 112th exit only access with electronic gates, and to install an entrance

feature at NW 75th Lane and NW 114th with an electronic gate that allows for public access is hereby approved subject to the following conditions:

- 1. Applicant shall obtain approval from Miami-Dade County.
- 2. The applicant shall submit engineering plans, showing the closure, to the City's Public Works Department for review and approval.
- 3. The closure of electronic gates along NW 114th Avenue shall not occur until the completion of NW 114th Avenue.

<u>Section 2.</u> This Resolution shall be recorded in the Public Records of Miami-Dade County, Florida and the Applicant shall pay the costs of recording said document.

<u>Section 3.</u> This resolution shall become effective upon its passage and adoption by the City Council.
