Professional Services:

Architectural, Electrical and Mechanical Engineering services for the City of Doral.

Project Description:

The project consists in the conversion of the Community Policing Officers Area and P.M. Motor Squad Area into a Simulation Room withing the Police Substation Facility. The City of Doral Police Substation Facility is located at 3719 NW 97th Ave, Doral FL, 33178.

Scope of Services:

- A new set of double doors will be provided at the Public Lobby Area.

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND A&P CONSULTING TRANSPORTATION ENGINEERS CORP. FOR THE PROVISION OF ARCHITECTURAL AND ENGINEERING DESIGN TO DEVELOP A SET OF CONSTRUCTION DOCUMENTS AND TO PROVIDE POST DESIGN SERVICES FOR THE DORAL POLICE TRAINING AND COMMUNITY CENTER SIMULATION ROOM IN AN AMOUNT NOT TO EXCEED \$22,000.00; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, as the City continues to grow, there is a need for the City's facilities to adapt and transform in order to ensure staff can provide the community a better service and to accommodate the needs of a growing City staff; and

WHEREAS, during these difficult times the City of Doral Police Department seeks to develop a simulation room at the Police Training and Community Center in order to facility simulation and one-on-one training to Police Officers; and

WHEREAS, the PWD reached out to APCTE to review the Police Department needs and to request a proposal for the Architectural and Engineering design services to develop a set of construction documents and to provide Post Design Services for the proposed Simulation Room; and

WHEREAS, APCTE is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

WHEREAS, City staff respectfully requests that the Mayor and City Council Members approve a Work Order for APCTE for the provision of Architectural and Engineering design services to develop a set of construction documents and to provide Post Design Services for the Doral Police Training and Community Center Simulation Room (Training Room) in an amount not to exceed \$22,000.00; and

WHEREAS, funds for these services are available in the current Fiscal Year Police Fund — "Red Safety Light Cameras Account", Account No. 001.60005.500343, \$97,000.00, which is being presented at the September 2020 Council Meeting for transfer by the Police Department to the Police Fund — "Construction In Progress Account", Account No. 001.60005.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

<u>Section 2.</u> Approval. The Work Order between the City of Doral and APCTE for the provision of Architectural and Engineering design services to develop a set of construction documents and to provide Post Design Services for the Doral Police Training and Community Center Simulation Room (Training Room) in an amount not to exceed \$22,000.00, a copy which is attached as Exhibit "A", is hereby approved.

<u>Section 3.</u> <u>Authorization</u>. The City Manager is authorized to execute the Work Order and expend budgeted funds on behalf of the City in furtherance hereof.
