

**RESOLUTION No. 16-205**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDED INVITATION TO BID# 2016-13 "HARLEY DAVIDSON POLICE LHP ROAD KING MOTORCYCLE LEASES" TO PETERSON'S HARLEY DAVIDSON OF MIAMI, INC.; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH PETERSON'S HARLEY-DAVIDSON OF MIAMI, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE 24 MONTH LEASE AGREEMENT OF THIRTEEN (13) 2017 HARLEY DAVIDSON POLICE LHP ROAD KING MOTORCYCLES TO INCLUDE SPARES, MAINTENANCE AND SUPPORT SERVICES IN THE AMOUNT OF \$187,200.00, AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the "City") issued Invitation To Bid 2016-13, Harley Davidson Police Lhp Road King Motorcycle Leases (the "ITB") was issued on May 25, 2016 for the purpose of leasing thirteen (13) 2017 Harley Davidson Police LHP Road King Motorcycles for Motor Patrol Officers, the center piece of the Traffic Enforcement Division and the City's 3 "E's" of traffic management: Engineering, Education and Enforcement; and

**WHEREAS**, the ITB was advertised on DemandStar and the City's Web Site, with one (1) submittal received and opened by the June 27, 2016 deadline; and

**WHEREAS**, Peterson's Harley Davidson of Miami, Inc. was found to be the Lowest most Responsible and Responsive Bidder.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Award.** The ITB is hereby awarded to Peterson's Harley Davidson of Miami, Inc., the lowest, most responsive and responsive bidder, subject to entering into an agreement with the City on the same or substantially similar terms as presented in the Peterson's Harley Davidson of Miami, Inc.'s bid. The award of this ITB does not, in and of itself, constitute a vested right to the Peterson's Harley Davidson of Miami, Inc.

**Section 3. Authorization to Procure Services.** The City Manager is hereby authorized to negotiate and execute an agreement and other construal documents, subject to approval by the City Attorney as to form and legal sufficiency, with Peterson's Harley Davidson of Miami, Inc., in an amount not to exceed \$187,200.00, for the twenty-four (24) month lease agreement of thirteen (13) 2017 Harley Davidson Police LHP Road King Motorcycles to include spares, maintenance and support services, and to expend budgeted funds in furtherance hereof.


**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This resolution shall take effect immediately upon adoption.
