A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ADOPTING THE CONCEPTUAL PARK DESIGN FOR DORAL NORTH PARK AND AUTHORIZING CITY MANAGER TO ISSUE REQUEST Α QUALIFICATIONS FOR CONSTRUCTION DOCUMENTS. PROJECT **BIDDING** ASSISTANCE, AND **MANAGEMENT** SERVICES OF THE PARK PROPERTY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral owns +/- twenty-five (25) acres of land at the corner of NW 97^h Avenue and NW 74th Street and wishes to develop it into a park; and

WHEREAS, Doral North Park will serve the surrounding community with parks and recreation amenities not currently available, improving quality of life, and providing residents with safe green spaces; and

WHEREAS, the conceptual park design is consistent with the requirements established in the Management Plan approved by the Florida Communities Trust and the Florida Department of Environmental Protection's Land and Water Conservation Fund grant award for this site; and

WHEREAS, Staff respectfully requests that the City Council adopt the conceptual park design for Doral North Park and authorize the City Manager to issue a Request for Qualifications for the provision of construction documents, bidding assistance, and project management services for the development of the park property.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:
