If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

This Work Order incorporates the terms and conditions set forth in the Professional Services Agreement dated January 4, 2021, between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. This Work Order is not binding until the City of Doral agrees and approves this Work Order.

WHEREAS, the City of Doral ("City") Public Works Department (PWD) is in need of a firm to provide design services for the Citywide Sidewalk Improvements Phase III Project as a continuation to the completed Phase II project; and

WHEREAS, the design services include topographical survey, utility coordination, development of construction plans, permitting with regulatory agencies, and other tasks as detailed in Marlin's proposal; and

WHEREAS, City staff respectfully requests that the City Council approve Work Order No. 13 with Marlin, a copy of which is attached hereto as Exhibit "A", for the provision of design and permitting services for the Citywide Side walks Improvements Phase III Project in an amount not to exceed \$100,297.00; and
