

**RESOLUTION No. 20-74**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN SPECIAL EVENT PERMIT FOR WALMART CO-SPONSORED BY THE CITY OF DORAL TO HOST THE “COVID-19 TESTING SITE” EVENT AT WALMART LOCATED AT 8651 NW 13 STREET, DORAL, FL 33126, ON MONDAYS, WEDNESDAYS AND FRIDAYS BEGINNING ON MONDAY, MAY 11, 2020 DURING THE COVID-19 STATE OF EMERGENCY, FROM 7:00 AM TO 9:00 AM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Walmart (“Applicant”) seeks approval from the City of Doral for a Special Event Permit; and

**WHEREAS**, staff recommends Council to approve the proposed cosponsored Special Event Permit to host the “COVID-19 Testing Site” Event on Mondays, Wednesdays and Fridays, Monday, May 11, 2020 during the COVID-19 State of Emergency, located at Walmart, 8651 NW 13<sup>th</sup> Street, Doral, FL, 33126.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.
