RESOLUTION No. 09 - 98

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ADOPTING THE COMPETITIVELY BID TERMS BETWEEN THE CITY OF TAMARAC AND MARTIN OUTDOOR MEDIA, INC. FOR THE PROVISION OF A BUS PASSENGER BENCH PROGRAM IN THE CITY OF DORAL; DIRECTING THE CITY MANAGER AND THE CITY ATTORNEY TO NEGOTIATE A CONTRACT ON THE BASIS OF SAID TERMS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Public Works Department has identified the need for bus benches in several locations throughout the City; and

WHEREAS, after carefully reviewing several contracts and styles of benches, Staff respectfully requests that the City Council to waive the Request for Proposals Process and adopt the competitively bid contract between the City of Tamarac and Martin Outdoor Media, Inc. (Martin) for the provision of a bus passenger bench program; and

WHEREAS, following discussions with Martin, the City was able to obtain more favorable terms than some of the existing contract provisions with the City of Tamarac which include revenue to the City based upon the higher of a per bench fee or percentage of revenue generated as well as up to 20% of the benches to be placed without advertisements; and

WHEREAS, Staff further respectfully requests that the City Council direct the City Manager and the City Attorney to negotiate a contract with Martin on the basis of said terms.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF DORAL AS FOLLOWS:

<u>Section 1.</u> The City Council of the City of Doral hereby adopts the competitively bid terms between the City of Tamarac and Martin Oudoor Media, Inc. for the provision of a bus passenger bench program.

<u>Section 2.</u> The City Council further directs the City Manager and the City Attorney to negotiate a contract with Martin on the basis of said terms.

<u>Section 3.</u> This Resolution shall take effect immediately upon adoption.
