A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND GANNETT FLEMING, INC., A PREQUALIFIED VENDOR, FOR THE PROVISION OF DESIGN SERVICES AND THE DEVELOPMENT OF CONSTRUCTION PLANS FOR THE WIDENING OF NW 82 AVENUE FROM THREE LANES TO FIVE LANES BETWEEN NW 27 STREET AND NW 33 STREET IN AN AMOUNT NOT TO EXCEED \$187,057.03; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City"), by and through the Public Works Department, wishes to secure a firm for the provision of design services and the development of construction plans for the widening of NW 82 Avenue from three (3) lanes to five (5) lanes between NW 27 Street and NW 33 Street; and

WHEREAS, Gannett Fleming, Inc. is a prequalified provider of professional engineering services selected in accordance with the requirements of Florida's Consultant Competitive Negotiation Act and the City's Procurement Code and approved by the City Council in December 2014; and

WHEREAS, Staff recommends that the City Council approve the Work Order with Gannett Fleming, Inc. for the provision of design services and the development of construction plans for the widening of NW 82 Avenue from three (3) lanes to five (5) lanes between NW 27 Street and NW 33 Street; in an amount not to exceed \$187,057.03.

This Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 2, 2015 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.
