A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ACCESS TIPS CONTRACT No. 220105 PURSUANT TO SECTION 2-322 OF THE CITY OF DORAL CODE OF ORDINANCES, FOR THE RENEWAL, MAINTENANCE AND SUPPORT OF THE CITY'S FIREWALL IN AN AMOUNT NOT TO EXCEED \$58,809.86 FOR A ONE (1) YEAR PERIOD; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral utilizes the firewall as the primary defense against cyber threats. It prevents unauthorized access, malware, and other malicious activities from compromising our sensitive data and systems; and

WHEREAS, with the increasing reliance on technology and the growing threat of cyberattacks, phishing, ransomware, and other cyber intrusions, the city has been taking proactive steps to strengthen its cyber security; and

WHEREAS, notably, Section 119.0725 (b), Florida Statutes, creates a public records exemption related to cybersecurity. Specifically, the statute makes any information related to critical infrastructure such as this confidential and exempt from public record requirements. In addition to the public records exemption, any portion of a meeting that might reveal such information is exempt from public meeting requirements. See Section 119.0725(3), Florida Statutes; and

WHEREAS, pursuant to Section 2-322 of the City's Code of Ordinances, the City is authorized to purchase supplies, materials, equipment and contractual services which are the subject of contracts through cooperative purchasing ventures, when the best interest of the City would be served thereby; and

WHEREAS, the City Manager recommends that the City Council approve the renewal of firewall maintenance and support in an amount not to exceed Fifty Eight Thousand, Eight Hundred Nine Dollars and 86/100 (\$58,809.86.).

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval and Authorization. The renewal of firewall maintenance and support in an amount not to exceed Fifty-Eight Thousand, Eight Hundred Nine Dollars and 86/100 (\$58,809.86), from Clarium Managed Services is hereby approved, and the City Manager is authorized to purchase from Clarium Managed Services utilizing TIPS Contract #220105, subject to City Attorney approval as to form and legal sufficiency. The City Manager is further authorized to expend budgeted funds as provided for herein. Funding will be provided via the IT Maintenance and Repair account number 001.22005.500460.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution, including, as necessary, negotiating the terms of an agreement in furtherance of the approved purchase.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
