A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDING INVITATION TO BID #2022-07 "LICENSE PLATE READER INFRASTRUCTURE CONSTRUCTION" TO HORSE POWER ELECTRIC INC., AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH HORSEPOWER ELECTRIC INC, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The City of Doral desires to retain the services of, a qualified General Engineering CONTRACTOR to construct the infrastructure for the License Plate Reader System. The Contractor must be qualified to perform work on Miami-Dade County and FDOT Traffic Signal; and

WHEREAS, ITB No. 2022-07 License Plate Reader Infrastructure Construction was issued on March 17th, 2022, and advertised on the City's Website, Vendor Registry and on DemandStar. One (1) person representing one (1) firm attended the non-mandatory pre-bid meeting that was held on March 31st, 2022. One (1) submittal was received and opened on April 18th, 2022, with the firm meeting the minimum required criteria set forth in the ITB; and

WHEREAS, On June 13, 2018, Mayor and Council approved Resolution 18-100 to Horsepower Electric Inc. for LPR Phase (two) 2 project which consisted of two (2) City intersections and seven (7) poles of which need to have, design, underground directional bore, conduits, fiber cables, installation of all poles and electrical services for all intersection; and

WHEREAS, On September 17, 2017, Mayor and Council approved Resolution 17-

157 for award ITB #2017-25 to Horsepower Electric for LPR Phase (one) 1 project which consisted of 6 City intersections and 22 poles of which 16 needed to have design, underground directional bore, conduits, fiber cables and electrical services from the main intersection pole at each location to the other poles in the; and

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The City Manager's Office respectfully requests that the Mayor and City Councilmembers authorize the Acting City Manager to enter into an agreement with Horsepower Electric Incorp. for the License Plate Reader Infrastructure and any associated equipment and or technology to ensure that it functions properly

<u>Section 3.</u> <u>Authorization.</u> The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
