

RESOLUTION No.18-101

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF SEVEN (7) AXIS CAMERAS AND ACCESSORIES FROM B & H PHOTO AND ELECTRONICS CORPORATION TO COMPLETE THE LICENSE PLATE READER (LPR) GRID PHASE 2; FOR A TOTAL NOT TO EXCEED AMOUNT OF \$19,691.00; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS FOR THE PURCHASE OF SAME; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Information Technology Department is working on the FY17-18 Strategic Plan Smart City Priority to Complete the License Plate Reader (LPR) Grid-Phase 2. The Axis cameras and accessories that will be mounted on seven (7) LPR poles for video surveillance at each intersection. This Phase 2 consist of adding two (2) (entry/exit) intersections to the License Plater Reader Grid that will have seven (7) LPR and seven (7) video streaming cameras that are monitored at Police Dispatch Center; and

WHEREAS, B & H Photo and Electronic Corporation provided the City the lowest quote, attached hereto as Exhibit "A"; and

WHEREAS, The Information Technology department recommends the City Council approve the Resolution authorizing the City Manager to purchase seven (7) Axis Cameras and Accessories from B&H Photo and Electronics Corporation at a cost of \$19,691.00; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 3. Approval of Goods and Services. The procurement of seven (7) Axis Cameras and Accessories from B&H Photo and Electronics Corporation at a cost of \$19,691.00.

Section 3. Authorization. The City Manager is hereby authorized to consummate the procurement of the good and services contemplated herein. The City Manager is further authorized to expend budgeted funds in furtherance hereof.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
