

RESOLUTION No. 20-20

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ADOPT THE NASPO AGREEMENT No. 1797349 WITH ATT MOBILITY SERVICES FOR CITYWIDE TRACKING OF VEHICLE FLEET VIA GPS SOFTWARE AND ATT'S FIRSTNET SOLUTION OF WIRELESS VOICE, TEXTING AND DATA SERVICE PLANS IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS, FOR THE PERIOD SET FORTH AND ANY APPROVED ADDITIONAL SUBSEQUENT EXTENSIONS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") seeks the access to The NASPO Agreement #1797349 AT&T Mobility Services for citywide tracking of vehicle fleet via a GPS software and AT&T Firstnet Solution consisting of a portfolio of wireless voice, texting and data service plans; and

WHEREAS, section 2-322 of the City Code of Ordinances provides that the City may enter into contracts competitively entered into by other governmental entities; and

WHEREAS, the use of cooperative procurement contracts is in the best interest of the City as its usually based on the common requirements of multiple governments. Most cooperative purchasing efforts involved bulk commodities with standard specifications; and

WHEREAS, staff respectfully recommends the Mayor and City Council Members to adopt The NASPO Agreement No. 1797349 AT&T Mobility Services for citywide tracking of vehicle fleet via a GPS software and AT&T's FirstNet Solution consisting of a portfolio of wireless voice, texting and data service plans, along with ancillary equipment, services, features and functionalities developed by AT&T; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Authorization. The City Council hereby authorizes the City Manager to sign any and all necessary documents, to access The NASPO Agreement No. 1797349 AT&T Mobility Services for citywide tracking of vehicle fleet via a GPS software and AT&T's FirstNet Solution consisting of a portfolio of wireless voice, texting and data service plans, along with ancillary equipment, services, features and functionalities developed by AT&T in an amount not to exceed budgeted funds, for the period set forth NASPO Agreement No. 1797349 and any approved additional subsequent extensions.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the provisions of this Resolution.
