A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN AGREEMENT WITH VRC COMPANIES, LLC FOR THE PROVISION OF RECORDS STORAGE AND RECORDS MANAGEMENT SERVICES, UTILIZING A CITY OF TAMPA CONTRACT IN AN AMOUNT NOT TO EXCEED ANNUAL BUDGETED FUNDS; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") has been utilizing the records storage and records management services of Certified Records Management, Inc. ("CRM") since 2010 based on the competitively bid agreement with South Florida Waste Management, and subsequently with the City of Tampa since 2015, attached hereto as Exhibit "A"; and

WHEREAS, CRM offers document management services, data protection services, certified destruction services, and digital document solutions and maintains records in a state-of-the-art facility that is situated in a no flood area and designed to withstand a Category 5 hurricane; and

WHEREAS, the City has an on-going need to preserve and protect public records; and

WHEREAS, on September 30, 2022, Certified Records Management submitted an Assignment, Assumption and Consent Agreement for a name change to VRC Companies, LLC ("VRC") to the City of Tampa, who approved their existing agreement through September 30, 2023 via City of Tampa Resolution 2023-145; and

WHEREAS, said agreement as assigned to VRC, provided for a renewal under the same terms and conditions as contained in the original agreement, and the parties agreed to such extension; and

WHEREAS, on September 7, 2023, the City of Tampa approved the renewal of the agreement with VRC through September 30, 2024 via City of Tampa Resolution 2023-857; and

WHEREAS, on June 18, 2024, the City of Tampa issued a renewal solicitation for said services RFP 61072924, set to open on August 27, 2024; and

WHEREAS, on August 26, 2024, the City of Tampa issued an extension letter to VRC Companies, LLC, extending their services through November 30, 2024 while the solicitation becomes awarded; and

WHEREAS, Section 2-322 of the City Code of Ordinances authorizes the City Manager to purchase from (piggyback) a contract entered into by another governmental or public entity, provided that the City Manager has determined that it is practicable and advantageous for the City to employ this method of procurement and that the governmental or public entity has followed a competitive bidding procedure leading to the award of the bid or contract; and

WHEREAS, in an effort to reduce costs related records storage and management and the costs of procuring same, the City Clerk has recommended that the City Council continue to utilize the services of VRC and adopt the competitively bid terms of the agreement between VRC and the City of Tampa for the provision of records storage and records management services.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The agreement between the City of Doral and VRC, utilizing the City of Tampa agreement, for the provision of records storage and management, is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement with VRC, and to expend annual budgeted funds on behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.

All proposals received after the due date and time shall be rejected. **Offers by mail, hand delivery or express mail, telephone, email or transmitted by facsimile (FAX) machine are not acceptable.** All submittals are uploaded electronically into the GETALL system. **No file shall have a special character**. No proposal may be withdrawn or modified after the time fixed for the opening of proposals.

To ensure that an electronic submittal is received by the opening date and time, it is recommended that the Proposer submit their documents with adequate time allowed prior to the deadline. The Proposer shall be responsible for confirming that their submittal is received by the deadline. Any submittal received after the closing date and time will not be considered.

EXHIBIT 1 CITY OF TAMPA INSURANCE REQUIREMENTS

SECTION I. SCOPE OF SERVICES

1. INTRODUCTION

The City Clerk's Office of the City of Tampa (City) is seeking proposals from qualified companies to provide all necessary facilities, equipment, protection devices, supervision, labor, and transportation to perform storage and indexing, retrieval, certified record destruction, pick up, delivery, and miscellaneous services for various type records. These records include, but are not limited to, drawings, boxed records, back-up tapes, magnetic and microform media, video and audio tapes, miscellaneous printed and stored materials, etc. for archival, semi-active and inactive records. The City prefers that all services required under the RFP be maintained and kept at one facility.

2. BACKGROUND

Tampa is the largest city on Florida's Gulf coast, with a population approaching 342,100. Florida Statutes and a City Ordinance on records management establishes the legal basis for the custody and disposal of public records, public access to those records, and to establish and coordinate standards, procedures, and techniques for efficient and economical records making and keeping. By law, the City Clerk administers the City's Archives and Records Service. The Archivist/Records Manager is responsible for day-to-day operations of the Archives and Records Service Center.

Four major functions are part of the center:

- Archiving
- Storing inactive records
- Microfilm and media storage
- Disposition of records

The City has estimated that there are approximately 33,000 cubic feet of records currently being stored.

The average archival services per month are:

- New Inventory 200 boxes
- Retrievals 100 items
- Disposition 415 boxes

3. CATEGORIES OF SERVICE

There are several categories of records management services that are required by the City. The categories of service are:

- **3.1 ARCHIVAL SERVICE**. Provides for the long-term storage of boxes of historical records in climate-controlled space. A specialized, non-water fire-suppression system is used in a climate-controlled storage vault such as Halon, FM200 or an approved equivalent; equivalency and suitability of system is to be determined at the City's sole discretion.
 - **3.2 FILE LEVEL SERVICE**. Provides for access, retrieval and re-file of individual files.
 - **3.3 BOX LEVEL.** Provides for access, retrieval and re-file of boxes of inactive and archival materials.
- **3.4 DELIVERY**. The City may, or may not, choose to perform courier services to and from the facility's site. However, if service is required, deliveries and/or pick up of new material or the pick-up of records to be re-filed shall be accomplished by the end of the next business day or within 2 hours for rush orders after notification by a fax, phone request, or internet email to the designated location.

3.5 ADDITIONAL SERVICES. Record services include, but are not limited to, the following: retrieval, pick up, rush special delivery, regular schedule delivery, miscellaneous labor services, destruction of records, transportation to new location, and services performed outside business hours.

4. MOVING REQUIREMENTS

This Section applies only in the event that the records be moved from the current provider to the Successful Proposer immediately preceding the award.

The records are currently stored in a record storage facility located in Tampa, Florida. The City has estimated that there are approximately 33,000 cubic feet of various type records currently in storage. It is the responsibility of the Proposer to include the cost of moving the records from the current location to its facility within the proposal being submitted.

The City will coordinate with the current provider and the Successful Proposer the transfer of records from the current location to the new location.

The Successful Proposer shall prepare an inventory of all records as they are being moved into the storage facility based on the existing barcode labels on the records and prepare an index. All such moving, inventorying, and indexing shall be completed within 30 calendar days, or a mutually agreed upon time frame, from receipt of City's purchase order and shall be performed so as to allow users reasonable access to all records throughout the process. Upon completion the Successful Proposer shall furnish the City with a copy of the index and supporting inventory. Work papers and supporting documents, either original paper or legible xerographic copies relating to the inventory, shall also be supplied to verify the accuracy of the data entry to the index. Clarification of any discrepancies shall be furnished within 5 working days.

5. PROPOSER REQUIREMENTS

The Successful Proposer shall perform storage, inventory, destruction, and indexing services in accordance with the terms of this RFP in a storage facility meeting the requirements set forth herein. The Successful Proposer's facility must comply with Florida Administration Code Rule 1B-24 and Chapters 119 and 257 of Florida Statutes regarding storage, retention, and records destruction procedures.

- **5.1** The Successful Proposer shall maintain a current inventory and index of boxed records in storage on barcode-enabled software. The City currently uses Hewlett Packard Enterprise (HPE).
- **5.2** This inventory database of City records shall at all times be the sole property of the City. The Successful Proposer shall provide the City with a copy of the latest database, in the requested format, as needed.
- **5.3** The Successful Proposer shall provide a copy of each New Material Transfer Sheet to Records Retention within three calendar days after receipt of shipments of new or boxed records from the user. The New Material Transfer Sheets shall be annotated with the Successful Proposer's assigned identification numbers corresponding to the City Box Number in order to allow the City to verify the receipt, indexing, and processing of new boxes of records to storage. The integrity of the index and inventory of boxes of records in storage are essential to the management of the City's records. The Successful Proposer must provide for the verification of the data and any corrections to the index and inventory database. New Material Transfer Sheets are provided by the Successful Proposer and completed by authorized City personnel.
- **5.4** A phone number shall be provided for fax service requests during normal business hours (8:00 AM through 5:00 PM, Monday through Friday). Numbers shall be changed only after verbal notification and written notice has been received by the City. The primary methods of making a service request shall be via facsimile, phone, or internet e-mail.
 - **5.5** The Successful Proposer shall provide website access to review the City's inventory and account.
 - **5.6** The Successful Proposer shall provide the capability for submitting service requests via Internete-mail.

- **5.7** There shall be a 24-hour telephone number to call for service during and after business hours, which shall be answered at all times by an employee of the Successful Proposer. Upon request, the Successful Proposer shall provide telephone reference concerning the records on a 24-hour basis by dispatching personnel to the storage facility to read from the records over the telephone to authorized City personnel. That number shall be changed only after verbal notification and written notice has been received by the City.
- **5.8** The Successful Proposer shall not store any City records in any other storage facility/facilities other than the original proposed record facility/facilities without prior written approval from the Archivist/Records Manager or designated representative.
- **5.9** The Successful Proposer shall be a good standing member of the Association of Commercial Records Centers.

6. MAGNETIC MEDIA STORAGE

The Successful Proposer will also provide services for the City's Technology and Innovation (T&I) Department for the purpose of storing and transporting critical COT data media (i.e., magnetic tape, cartridges, disks, CDs/DVDs, etc.) to and from the T&I facility located at 2555 E. Hanna Avenue, Tampa, FL 33610.

- **6.1** The storage site selected must:
 - Be FM-200/Halon (or dry suppressant equivalent) fire protected.
 - Have adequate humidity and temperature controls and redundant systems preferred.
 - Have a centrally monitored fire and intrusion alarm.
 - Have delivery vans that are climate controlled and equipped with FM-200/Halon (or equivalent) fire extinguishers.
 - Use lockable or secure fastener storage containers to transport media between ORM site and ITS computer facility. Containers are to remain locked during transit.
- **6.2** The Awardee must be able to use the City of Tampa's tape management system reports as a vehicle for pick-up and delivery of media between 6:30 AM and 8:30 AM.

7. STORAGE FACILITY REQUIREMENTS

- **7.1** The storage facility shall be located within 20 miles of Old City Hall, 315 E. Kennedy Blvd., Tampa, Florida and shall be approved by the City. It is preferred by the City, the facility is large enough to accommodate all the City's records and vault storage requirements.
- **7.2** The records storage facility shall have climate-controlled spaces with temperature and humidity regulation suitable for long-term hard copy records which is a maximum of 70 degrees Fahrenheit and a humidity level between 40% and 50% with a minimum of cycling that should be maintained at less than 10 degrees Fahrenheit and 10% humidity to prevent degradation of the paper.
- **7.3** The records storage facility shall be rated to withstand a Category 5 hurricane and cannot be located in any designated flood plains or flood zones.
- **7.4** The records storage facility shall be capable of providing at least 34,000 cubic feet of space for immediate use and an additional 3,500 cubic feet each year during the service term. The Successful Proposer will be compensated only for occupied storage space.
 - 7.5 The Successful Proposer shall provide electronic fire, burglary, and vandal detection systems that are

monitored on a 24-hour basis 7 days per week.

- **7.6** Records shall be stored in a fire-resistant building in accordance with "The State of Florida Public Records Storage Guidelines for Records Centers and Archives" equipped with an alarm, which is capable of notifying the Fire Department instantly of any apparent emergency. There must be a smoke detector plus an inert gas fire-suppressant system or a sprinkler system that covers the storage facility. Vital Records Storage, used for the storage of vital records, tapes and microfilm, shall have an inert gas fire-suppressant system, such as HALON or FM200 gas system or a dry pipe sprinkler system that covers the storage facility.
- **7.7** Storage vaults, constructed totally from noncombustible materials in accordance with "NFPA 232" and related fire codes, shall be provided for the storage of Vital Records consisting of magnetic media, microforms, and paper media. The various media shall be stored in separate vaults or, if stored in the same structure, must be separated by a fire wall of NFPA approved construction with appropriate fire-resistant doors and shall have an inert gas fire suppressant system, such as HALON or FM200 gas system.
 - **7.8** The records storage facility shall have:
 - A regular and standby/backup power supply sufficient to maintain proper archival environmental
 controls, security, fire detection, and suppression equipment and an HVAC system with adequate levels
 of control to establish and maintain archival storage conditions, including heating, cooling,
 dehumidification and humidification 24 hours per day regardless of electrical power conditions.
 - A slightly positive air pressure balance maintained within the records storage area so as to ensure a consistency of temperature and relative humidity and to minimize infiltration of contaminants. The facility shall maintain a temperature of 65 to 75 degrees, with a variation of no more than 2 degrees, and the relative humidity should remain at 45 to 55 percent, with a variation of no more than 5 percent.
 - The Proposer shall submit in its proposal the location of the facility where the City records will be stored.
 - **7.9** The temperature of the Vital Records Storage Vaults for computer magnetic tapes, microfilm, and paper records must be maintained within a range of 62 to 68 degrees Fahrenheit with a variation of no more than 2 degrees and relative humidity of 35% to 45% with a variation of no more than 5 percent.
- **7.10** The records for the City shall be stored in one facility. The City will not accept multiple storage facilities to store the records for the City. If multiple locations are proposed, the City reserves the right to consider the proposal non-responsive.

8. PERFORMANCE REQUIREMENTS

At the discretion of the City, the following "Level of Service" monetary deductions from Successful Proposer's invoice may apply for non-compliance.

- Lost or misplaced records over 24 hours \$100.00 each occurrence.
- Failure to deliver regular or rush delivery per reguest \$25.00 each occurrence.
- Improper Temperature/Humidity Control \$100.00 each occurrence.
- Failure to deliver or pick up for five consecutive business days \$100.00 a day until corrected.
- Three or more performance issues caused by the Successful Proposer within 60 days could result in notice of termination of award. The Successful Proposer will move City records according to the Archives Manager's direction to the new location at no cost to the City.

9. ACCESS TO RECORDS

9.1 Access to City records shall be limited to authorized City personnel as designated in writing. The Successful

Proposer shall maintain a sign-in sheet and require identification from all persons seeking access to the records. The Successful Proposer shall obtain from the City, and maintain on file, the list of authorized City Personnel.

9.2 The Successful Proposer shall provide reasonable on-site facilities to be used by authorized City personnel while examining records at the storage facility. A photocopy machine must be located within the records storage facility for use by authorized City personnel with copy charges as stated in Exhibit E, Fee Schedule.

10. DESTRUCTION OR REMOVAL OF RECORDS

- **10.1** The Successful Proposer agrees to destroy stored records from inventory and records picked up from City facilities only upon receipt of a written authorization signed by the Archivist/Records Manager.
 - **10.2** The method of destruction shall be by shredding the documents on request.
- **10.3** A certification of the destruction of records for all authorized records destruction shall be sent to the Archivist/Records Manager.

11. END OF AWARD TRANSFER

If requested by the City, upon termination or expiration of the Award, the Successful Proposer shall, within 30 calendar days, or on a mutually agreed upon schedule, transport the records to a new location designated by the City. If necessary, records shall be packed in boxes provided by the Successful Proposer at the City's expense and labeled in accordance with the index. If necessary, the Successful Proposer shall consult with the City with respect to any records whose index classification cannot be determined.

The retrieval and removal of records for the end of Award transfer shall be considered similar to a regular retrieval. Termination fees and/or permanent removal fees shall not be charged.

12. INVOICES

- **12.1** The Successful Proposer shall establish an account, or multiple accounts if necessary, for the City. Invoices for each account shall be sent to the attention of recordsmgmt@tampagov.net.
 - **12.2** The Successful Proposer shall provide a monthly invoice with the following supporting documentation:
 - **12.2.1** An itemized list of charges for record storage and other services by user account.
 - **12.2.2** A copy of a signed receiving document for each invoiced activity.

13. PEST CONTROL

The Successful Proposer shall keep the storage facility free of pests and rodents at all times. Upon request, the Successful Proposer must be able to substantiate verification of regular monthly pest and rodent exterminations at the storage facility throughout the service term.

14. DISASTER RECOVERY

The Successful Proposer shall have a disaster recovery plan. The plan shall address recovery procedures and methods in case of natural disaster or maleficent actions. The Successful Proposer shall be capable of responding to fire damaged records, water damaged records, and be able to irradiate and wipe down records subjected to mold or other contaminants if and when necessary.

15. PICK-UP AND DELIVERY CHARGES

The Successful Proposer shall provide pick-up and delivery services to various facilities at various locations throughout the City during 8:00 AM and 5:00 PM when necessary. Proposers can obtain a City Directory at www.tampagov.net, go to the search engine and type in "City Directory". **THE SUCCESSFUL PROPOSER SHALL CHARGE A FLAT FEE PER FACILITY WITH NO ADDITIONAL CHARGES PER BOX OR PER FLOOR.**

16. ESTIMATED QUANTITIES NOT GUARANTEED

The estimated quantities specified herein are not a guarantee of actual quantities, as the City does not guarantee any particular quantity of records for storage, retrieval or destruction services during the term of this award. The quantities may vary depending upon the actual needs of the user. The quantities specified herein are good faith estimates of usage during the term of this award. Therefore, the City shall not be liable for any contractual agreements/obligations the Proposer enters into based on the City using the services in the quantities specified herein.

17. PROPOSAL SUBMITTALS

- **17.1** The following must be submitted in the proposal:
 - Detailed Company profile and history.
 - Company's Operating Policies and Procedures.
 - Company's Credentials. Describe what expertise or unique capability your Company can provide the City.

Proposers who obtain specifications and plans from sources other than GetAll are cautioned that the proposal packages may be incomplete. The City will not accept incomplete proposals. The City is not responsible for errors and omissions occurring in the transmission or downloading of any solicitation documents, plans, or specifications from the GetAll system. 18.2 Addendum and Amendment to RFP. If it becomes necessary to revise or amend any part of this RFP, GetAll will provide notification of the Addendum to all prospective Proposers who received an original RFP notification making them a plan-holder. Addenda will be posted and disseminated by GetAll at least five days prior to the RFP opening date.

The material(s) supplied shall be guaranteed to be free from defect of composition, conception, and workmanship for a minimum period one-year from the date of installation and final acceptance by the City. Any parts or portions found not in accordance with this RFP will be rejected by the City and returned to the Successful Proposer at the Successful Proposer's expense for immediate replacement.

- **18.7 Copyrights and Patent Rights**. Proposer warrants that there has been no violation of copyrights, patent or other intellectual or proprietary rights in manufacturing, producing and/or selling the item(s) ordered or shipped as a result of this Proposal, and Successful Proposer agrees to indemnify, defend and hold the City harmless from any and all liability, loss or expense by any such violation including litigation costs and attorneys' fees through the appellate process, and damages which may be incurred by reason of any infringement at any time during the prosecution or after the completion of work.
- **18.8 Procurement Protest Procedures.** A protest must be filed with the Director of the soliciting Department within five (5) business days of posting the City's intent to award and may be filed by an actual Proposer, who is allegedly aggrieved in connection with the issuance of a proposal solicitation or pending award of any contract in any competitive process utilized by the City of Tampa for procurements of supplies, materials or services and construction of public improvements and has standing to protest under Florida Law. Any protest must be filed in accordance with the City of Tampa Code, Chapter 2, Article V, Division 3, Purchases and Contracts, Section 2-282, Procurement Protest Procedures.  - **18.12 Proposals Binding.** All proposals submitted shall be binding for 180 calendar days following the opening.
- **18.13 Non-Discrimination in Contracting and Employment.** The following provisions are hereby incorporated into any contract executed by or on behalf of the City of Tampa (City).

The Successful Proposer shall comply with the following Statement of Assurance:

During the performance of this Contract, the Successful Proposer herein assures the City, that said Successful Proposer is in compliance with Title VII of the 1964 Civil Rights Act, as amended, the Florida Civil Rights Act of 1992, and the City of Tampa Code of Ordinances, Chapter 12, in that the Successful Proposer does not on the grounds of race, color, national origin, religion, sex, sexual orientation, gender identity or expression, age, disability, familial status, or marital status, discriminate in any form or manner against said Successful Proposer's employees or applicants for employment.

The Successful Proposer understands and agrees that this Contract is conditioned upon the veracity of this Statement of Assurance, and that violation of this condition shall be considered a material breach of this Contract. Furthermore, the Successful Proposer herein assures the City that said Successful Proposer will comply with Title VI of the Civil Rights Act of 1964 when federal grant(s) are involved. This Statement of Assurance shall be interpreted to include Vietnam-Era Veterans and Disabled Veterans within its protective range of applicability.

The Successful Proposer further acknowledges and agrees to provide the City with all information and documentation that may be requested by the City from time to time regarding the solicitation, selection, treatment and payment of subcontractors, suppliers, and vendors in connection with this Contract. The Successful Proposer further acknowledges that it must comply with City of Tampa Code of Ordinances, Chapter 26.5.

18.14 Proposer's Criminal History Screening Practices. - **18.15 Equal Opportunity.** The City of Tampa hereby notifies all Proposers that all eligible businesses, including Small Local Business Enterprises (SLBEs) and Women/Minority Business Enterprises (WMBEs) will be afforded a full opportunity to participate in any Contract made by the City of Tampa pursuant to this present proposal matter and will not be subjected to discrimination on the basis of race, color, national origin, religion, sex, sexual orientation, gender identity or expression, age, disability, familial status, or marital status. The City of Tampa prohibits any person involved in City of Tampa contracting and procurement activities, to discriminate on the basis of race, color, national origin, religion, sex, sexual orientation, gender identity or expression, age, disability, familial status, or marital status.
- **18.16 Governing Law/Venue.** The laws of the State of Florida (without giving effect to its conflicts of law principles) govern all matters arising out of or relating to this Agreement, including, without limitation, its interpretation, construction, performance, and enforcement. The parties hereto submit to the exclusive jurisdiction and venue of the state and federal courts located in Hillsborough County, Florida.
- **18.17 Compliance with Laws.** The Successful Proposer shall comply with all applicable laws, ordinances, and codes of the Federal Government, State of Florida, Hillsborough County, and the City of Tampa. It shall be the responsibility of the Successful Proposer to be knowledgeable of all federal, state, county and local laws, ordinances, rules, and regulations that in any manner affect the items covered herein which may apply. Failure to comply with all applicable laws, ordinances and codes may lead to termination of the contract.
- **18.18 Force Majeure.** If a Force Majeure Event occurs, the party that is prevented by that Force Majeure Event from performing any one or more obligations under this contract (the "Nonperforming Party") will be excused from performing those obligations, on condition that it complies with its obligations herein. "Force Majeure Event" means, with respect to the Nonperforming Party, any event or circumstance, regardless of whether it was foreseeable, which was not caused by the Nonperforming Party, which prevents the Nonperforming Party from complying with any of its obligations under this contract, on condition that the Nonperforming Party uses reasonable efforts to comply with its obligations, except that a Force Majeure Event will not include any strike or other labor unrest that affects only one party, economic hardship of a party, an increase in prices, changes in market conditions, or a change of law. Upon the occurrence of the Force Majeure Event, the Nonperforming Party shall notify the other party in writing within ten (10) days of the occurrence of that the Force Majeure Event, its effect on performance, and how long that party expects the Force Majeure Event to last. Thereafter the Nonperforming Party shall update the other party as reasonably necessary. During a Force Majeure Event, the Nonperforming Party shall use reasonable efforts to limit damages to the other party and to resume its performance under this contract. The other party has the right to terminate the contract if the Non-Performing Party's Force Majeure Event continues for more than a reasonable time.
- **18.19 Survival.** Provisions in regard to licensing, indemnification, governing law venue and confidentiality shall survive termination of contract.
- **18.20 Conflict of Interest.** The City requires that the Successful Proposer provide professional, objective, and impartial advice and at all times hold the City's interest's paramount, strictly avoid conflicts with other assignments or their own corporate interests and act without any consideration for future work. The Successful Proposer has an obligation to disclose any situation of actual or potential conflict that impacts their capacity to serve the best interest of the City, or that may reasonably be perceived as having this effect. If the City, in its sole discretion, determines that a conflict of interest exists, such Successful Proposer shall not be considered for award of this Contract. Failure to disclose said situations may lead to the disqualification of the Successful Proposer or the termination of its Contract.

Any such interests on the part of the Successful Proposer or their employees, must be disclosed in writing to the City on **ATTACHMENT C - CONFLICT OF INTEREST DISCLOSURE FORM** that is included with this solicitation document and should be included under Section 20. Also, the Successful Proposer is aware of the conflict-of-interest laws of the State of Florida and the City of Tampa and agrees that they shall fully comply in all respects with the terms of said laws.

18.21 Audit Rights. Successful Proposer agrees that the City or its authorized representative shall have access to, and the right to audit, examine, or reproduce, the financial books and records of Successful Proposer related to Successful Proposer's performance under the contract. Successful Proposer shall retain all such records for a minimum period of six (6) years from the date of termination of the contract, including any renewal or extension hereof, or for such

longer period of time as required by federal or state law, and shall be extended until the completion of any audit in progress. Successful Proposer must keep all financial records in a manner consistent with generally accepted accounting principles. Successful Proposer must provide access during normal business hours to the requested records no later than ten (10) calendar days after the written request by the City or its authorized representative. If any audit reveals any material deviation from the contract requirements, any misrepresentations or any overcharges to the City, the City will be entitled to recover damages, as well as the cost of the audit. Notwithstanding the aforementioned, the City may on a case-by-case basis permit a company on the Scrutinized Companies with Activities in Sudan List, the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List, or the Scrutinized Companies with Activities in Iran Terrorism Sectors List, the Scrutinized Companies that Boycott Israel List, or are engaged in business operations in Cuba or Syria to be eligible to submit a proposal for, or enter into or renew a contract for goods or services if the conditions set forth in Section 287.135(4) of the Florida Statutes are met.

If the City determines the Successful Proposer submitted a false certification under Section 287.135(5) of the Florida Statutes upon submission of a proposal, entering into a contract, on contract renewal, or if the Successful Proposer has been placed on the Scrutinized Companies with Activities in the Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List or the Scrutinized Companies with Activities in Iran Terrorism Sectors List or is on the Scrutinized Companies that Boycott Israel List or is engaged in a boycott of Israel or is engaged in business operations in Cuba or Syria, the City shall either terminate the contract after it has given the Successful Proposer notice and an opportunity to demonstrate the City's determination of false certification was in error pursuant to Section 287.135(5)(a) of the Florida Statutes.

- **18.23 Data Collection.** Pursuant to Section 119.071(5)(a), Florida Statutes, social security numbers collected from Successful Proposers are used for identification, verification, and tax reporting purposes.
- **18.24 Indemnification.** The Contractor/Successful Proposer/Firm (collectively the "Firm") releases and agrees to defend, indemnify and hold harmless the City of Tampa, its officers, elected and appointed officials, and employees from and against any and all liabilities, losses, claims, suits, actions, causes of action, either at law or in equity, damages, charges, judgments, or expenses (including attorney's fees and court costs, whether at trial or appeal) which the City may suffer, sustain, incur, or in any way be subjected to by reason of or as a result of any act, negligence, or omission on the part of the Firm, its agents or employees, in the execution or performance of the obligations assumed under or incidental to, the Award/Contract/Agreement (collectively the "Agreement") into which the Firm and the City will enter, except when caused solely by the fault, failure, or negligence of the City, its agents, or employees. Firm's duty to defend is separate and apart from Firm's duty to indemnify and hold harmless and exists immediately upon presentation of written notice of a suit, claim or action of any nature to the Firm by a party entitled to a defense hereunder. If the above indemnity or defense provisions or any part of the above indemnity or defense provisions are limited by the provisions of Section 725.06, Florida Statutes or any other applicable law, then this section 18.24 shall be so limited to said section 725.06 and with respect to the part so limited, the monetary limitation on the extent of the indemnification shall be the greater of (i) the monetary

value of this contract, (ii) the coverage amount of Commercial general liability insurance required under the contract, or (iii) \$1 Million Dollars. Otherwise, the obligations under this section 18.24. will not be limited by the amount of any insurance required to be obtained or maintained under this contract. Firm's duties to defend and indemnify pursuant to this section 18.24 shall survive the early termination or expiration of the contract and shall continue in full force and effect so long as the possibility of any liability, claim or loss exists, unless otherwise prohibited by law. Nothing in this section or in the contract shall be construed as a waiver of any immunity from or limitation of liability the City, its officers, agents, and employees may have under the doctrine of sovereign immunity under common law or statute.

- **18.25 Contractor Background Checks.** When assigning employees to work on City property, the Successful Proposer shall check the backgrounds of each employee and notify the City's Employment Services Manager prior to assignment if candidates fall into one or more of the following categories:
 - Unable to pass 8 Panel Drug Screen
 - Has a felony or misdemeanor conviction involving violence, weapons, or crimes against a public official
 - Is a former City of Tampa employee
- **18.26 Employee Verification.** In accordance with Section 448.095, Florida Statutes, the Successful Proposer agrees to register with and utilize the U.S. Department of Homeland Security's E-Verify system to verify the employment eligibility of all new employees hired during the term of the contract for the services specified in the contract. The Successful Proposer must also include a requirement in subcontracts that the subcontractor must register with and utilize the E-Verify system to verify the employment eligibility of all new employees hired by the subcontractor during the contract term. If the Successful Proposer enters into a contract with a subcontractor, the subcontractor must provide the Successful Proposer with an affidavit stating that the subcontractor does not employ, contract with, or subcontract with an unauthorized alien. The Successful Proposer shall maintain a copy of such affidavit for the duration of the contract. If the City has a good faith belief that the Successful Proposer has knowingly violated Section 448.09(1), Florida Statutes, the City shall terminate the Contract with the Successful Proposer, and the Contractor may not be awarded a contract with the City for at least 1 year after the date on which the contract was terminated. The Successful Proposer is liable for any additional costs incurred by the City as a result of the termination of the contract. If the City has a good faith belief that a subcontractor knowingly violated the law, but the Successful Proposer has otherwise complied with the law, the City shall promptly notify the Successful Proposer and order the Successful Proposer to immediately terminate the contract with the subcontractor.
- **18.27 Responsible Vendor Determination.** The City of Tampa will not request documentation of or consider a Proposer's social, political, or ideological interests when determining if the Proposer is a responsible vendor and will not give preference to a Proposer based on the Proposer's social, political, or ideological interests.

19. QUESTIONS REGARDING SPECIFICATIONS OR PROPOSAL PROCESS

- **19.1** To ensure fair consideration for all Proposers, the City prohibits prospective Proposers' communication with any department or employee during the submission process. Questions relative to the interpretation of the Scope of Services or the proposal process shall be addressed to the City during the pre-proposal conference, or questions can be submitted via the GETALL system up to ten days prior to the RFP opening date and time.
- **19.2 Communication Policy.** During any solicitation period including any protest and/or appeal, no contact with City officials or employees, other than with the Analyst, the Director of Purchasing or the Legal Department, is permitted from any proposer. Such communication shall result in an automatic disqualification for selection in the pending solicitation and any subsequent City solicitations for a period of six (6) months, no matter the outcome of the solicitation or any protest and/or appeal.

20. CONTENT OF PROPOSALS

20.1 Proposer Responsibility. Proposers are advised that the City's ability to evaluate proposals is dependent in part on the Proposer's ability and willingness to submit proposals which are well ordered, detailed, comprehensive and readable. Clarity of language and adequate, accessible documentation is essential. Proposers should maintain the sequence of sections as they are depicted in the RFP. It is the Proposer's responsibility to examine all specifications and conditions thoroughly and comply fully with specifications and all attached terms and conditions.

It is the Proposer's responsibility to provide a full and complete written response that does not require interpretation or clarification by the City Representative. The Proposer is to provide all requested materials, forms, and information. The Proposer is responsible to ensure the materials submitted will properly and accurately reflect the Proposer specifications

and offering. During scoring and evaluation (prior to any interviews), the City Representative will rely upon the submitted materials and shall not accept materials from the Proposer after the RFP deadline; however, this does not limit the right of the City Representative to consider additional information (such as references that are not provided by the Proposer but are known to the City, or past experience by the City in assessing responsibility), or to seek clarifications as needed by the City.

20.2 Proposals should be prepared simply and economically, providing a straightforward, concise description of the Proposer's ability to fulfill the requirements of the proposal. The proposal submitted is the City's official record and recording of the RFP. Submit electronic copies in Acrobat Adobe PDF format. Pages must be identified with page numbers. File name should not contain special characters. Proposer must wait for confirmation of successful document upload.

If Proposer is declaring any portion of the proposal is Confidential and/or Proprietary a copy of proposal marked "REDACTED" should also be provided to the City with the original following the instructions stated under Section II. General Conditions, Subsection 18.4 Florida Public Records Law.

In order to ensure a uniform review process and to obtain the maximum degree of comparability, it is required that proposals be organized in the following manner and <u>identified with tabs (headings)</u>:

IN GETALL, THE FOLLOWING ITEMS SHOULD BE GROUPED AND UPLOADED INTO THE "MAIN SOLICITATION RESPONSE" SECTION:

- **Title Page.** Type the name of Proposer's firm, address, telephone number, name of contact person, email address, date, and the title of the RFP.
- **Table of Contents.** Include a clear identification of the written material by section and by page number.
- **Proposal Submittal Check List.** Complete and submit Attachment A. for compliance of certain requirements identified in the RFP package.
- **Tab 1. Addenda.** Include a copy of the addendum, or addenda associated with the RFP, if applicable. Incomplete proposals will not be considered.
- Tab 2. Florida Public Records Law. Include a written acknowledgement of the Florida Public Records Law requirements from Section II. General Conditions, Section 18. General Information, Subsection 18.4 including executed copy of Attachment B – Public Records Declaration or Claim of Exemption.
- **Tab 3. Conflict of Interest.** Include executed copy of Attachment C Conflict of Interest Form.
- **Tab 4. Response to Proposal.** Specifically state the Proposer's understanding of the work to be accomplished and make a positive commitment to perform the work in Section I. Scope of Services.
- **Tab 5. Section I, Scope of Services.** Include all the requirements and/or documentation requested under Section I. Scope of Services, Section 17. Proposer Submittals.
- **Tab 6. References.** Include a reference list of at least three clients to whom the Proposer has provided services similar to those being proposed to the City. This list will include the following information:

• **Tab 7. General Statement of Experience.** Include a written, verifiable statement of experience in providing and managing similar services. If the Proposer does not possess any

experience similar to the services required, Proposer shall provide any pertinent information or experience Proposer feels may qualify Proposer for consideration of award.

- **Tab 8. Operational Plan.** Include a narrative description and/or organizational chart outlining the methods of operation, operational structure, and services to be provided by the Proposer. This description should fully and completely demonstrate the Proposer's intended methods for servicing the requirements. Proposers are also encouraged to provide any other pertinent information that will assist the City in evaluating the proposed method of operation.
- Tab 9. Sub-Contracting Submittals. No Successful Proposer shall assign the contract or any rights or obligations thereunder without the written consent of the City. The Successful Proposer shall be required to perform with its own forces at least fifty-one (51) percent of the work, unless prior written consent to subcontract a greater percentage of the work first obtained by the City. In the event of such approved subcontracting, the Successful Proposer agrees to provide the City with written documentation relative to the Subcontractor(s) solicited, or that will be employed in this award, including but not limited to submittal of attached the following Schedule of Sub-Contracting Forms:
 - Schedule of All Sub-Contractors/Consultants/Suppliers Solicited MBD 10
 - Schedule of Sub-Contractors/Consultants/Suppliers to be Utilized MBD 20

These forms must be completed (including signatures) and submitted with all proposals. Submittals that do not contain these completed forms shall be deemed "non-responsive". Instructions on completing the forms are included after each form in this RFP package.

Subcontractor shall be defined as a business enterprise, firm, partnership, corporation, consultant, or combination thereof having a direct contract with a prime contractor for any portion of the advertised work that is awarded by the owner/owner's representative.

Supplier shall be defined as a business enterprise that either directly contracts with a Prime Contractor/Consultant or directly contracts with a Subcontractor under such Prime Contractor/Consultant to provide materials, supplies or equipment in connection with a Contract awarded by the owner/owner representative. A Supplier may be a regular dealer, distributor, or manufacturer.

IN GETALL, THE FOLLOWING ITEM SHOULD BE UPLOADED IN THE "COST PROPOSAL SECTION":

• **Tab 10. Compensation.** Submit an all-inclusive cost statement. Provide a detailed cost statement for providing the services indicated in Section I. Scope of Services. Itemize fees, expenses, and any optional costs separately.

The Proposer and its staff assigned to provide Services for the City shall include travel and accommodation expenses in the proposal price. The Proposer shall comply with the City's current travel policy; coach/business class airfare seven-day advance booking, medium rate hotel accommodations if applicable, economy/midsize car rental and per diem of Breakfast \$8.00, Lunch \$12.00, Dinner \$18.00, and current IRS mileage reimbursement rate. Original receipts must be submitted in order for the Successful Proposer to be reimbursed for travel expenses.

IN GETALL, THE FOLLOWING ITEMS SHOULD BE GROUPED AND UPLOADED IN THE "SOLICITATION SUBMITTAL SECTION":

- **Tab 11. Proposer's Affidavit.** Complete, submit and have notarized the Proposer's Affirmation form provided in the RFP Package. This form must be signed by an authorized representative of the firm as defined below.
- **Tab 12. Affidavit of Compliance.** Complete, submit and have notarized the Affidavit of Compliance with Foreign Countries of Concern Pursuant to Section 287.138, Florida Statutes (2023)

form provided in the RFP Package. This form must be signed by an authorized representative of the firm as defined below.

• **Tab 13. Proposal Signature Form.** Complete and submit the Proposal Signature form and Requested Voluntary Information Regarding Proposer's Initial Employment Application Content form provided in the RFP Package. These forms must be signed by an authorized representative of the firm as defined below:

When Proposer is a corporation, the president, vice president or other person duly authorized to bind the corporation shall set out the corporate name in full beneath which he/she shall sign his/her name and give the title of his/her office or position. The proposal shall also bear the seal of the corporation attested by its corporate secretary. Proposals signed by a person other than an officer of the corporation, shall be accompanied by evidence of authority.

When the Proposer is a partnership, the proposal shall be signed in the name of the partnership by a general partner or other person duly authorized to bind the partnership. The capacity and authority of the person signing shall also be given.

When the Proposer is an individual or sole proprietorship, the proposal shall be signed by the individual owner, stating name and style under which the Proposer is doing business.

If the Proposer is doing business under a fictitious name, the Proposer must submit a copy of Certificate of Registration with the Florida Secretary of State.

When the Proposer is a joint venture, each joint venturer must sign the proposal as hereinabove indicated.

NOTE: Failure to submit the Proposal Signature Form **executed** or failure to **submit** the Proposal Signature Form in the proposal package will result in the proposal being <u>non-responsive</u>. **NO EXCEPTIONS.**

• Tab 14. Per Section 18.14 Proposer's Criminal History Screening Practices. Include documentation as referenced.

21. EVALUATION OF PROPOSALS

21.1 The City will not be under any requirement to complete the evaluation by any specific date and reserves the right to suspend or postpone the evaluation process should the need arise due to budget constraints, time constraints or other factors as directed by the City. However, it is anticipated that the review/evaluation process will be completed in a timely manner.

A Proposal Evaluation Committee will be established to review and evaluate all proposals submitted in response to this RFP. The Committee shall conduct a preliminary evaluation of all proposals on the basis of the information provided and other evaluation criteria as set forth in this RFP. The contract will be awarded to the most qualified Successful Proposer per the evaluation criteria listed below.

- **21.2 Application of WMBE and SLBE Evaluation Points.** During the evaluation of proposals for WMBE and SLBE participation, the Equal Business Opportunity (EBO) Office will be responsible for assigning the points under these criteria. Points are determined per MBD Form 71 (EBO Guidelines for Evaluation Points on Request for Proposals) which is attached to this RFP document.
- **21.3** Proposals will be evaluated and rated based on the criteria stated in this RFP, including but not limited to the following:
 - **21.3.1** Responsiveness of the Proposal to the scope of work.
 - **21.3.2** Ability, capacity, and skill of the Proposer to perform the scope of work.
- **21.3.3** Experience of the business and individual members of the business in accomplishing similar services.
 - **21.3.4** Responses of the client references.
 - **21.3.5** Such other information that may be required or secured.

21.4 SHORT-LISTING

The Evaluation Committee at its sole discretion may create a short-list of the highest scored proposals based on the preliminary evaluation against the evaluation criteria. Only those short-listed Proposers would be invited to participate in interviews and/or presentations, demonstrations, or product testing. Upon conclusion of any interviews and/or presentations, demonstrations or product testing, the Evaluation Committee will finalize the scoring against the evaluation criteria.

21.5 INTERVIEWS/DEMONSTRATIONS

If requested, Proposers may be required to participate in on-site interviews and conduct demonstrations to the City's Evaluation Committee and other City representatives, in order to clarify the proposal submitted and present the Proposer's proposed solution. Additionally, the Proposer's key personnel may be required to be in attendance during this process.

Proposers should be prepared to discuss and substantiate any of the areas of the proposal submitted, as well as its qualifications to furnish the specified products and services. The interviews and demonstrations will be scored by the Evaluation Committee.

Notwithstanding the possibility of a request for an on-site interview and demonstrations, Proposers shall not rely on the possibility of such a request and shall submit a complete and comprehensive written response to this solicitation. Any costs incurred for the interviews and the oral demonstrations are the responsibility of the Proposer.

- **21.6** The City reserves the following rights to:
- **21.6.1** Conduct pre-award discussion and/or pre-award negotiations with any or all responsive and responsible Proposers who submit proposals determined to be reasonably acceptable of being selected for award; conduct personal interviews or require presentations of any or all Proposers prior to selection; and make investigations of the qualifications of Proposers as it deems appropriate, including, but not limited to, a background investigation conducted by the Tampa Police Department or any other law enforcement agency.
- **21.6.2** Request that Proposer(s) modify its proposal to meet the needs of the City more fully, including Best and Final Offer(s) (BAFO), or to furnish additional information as the City may reasonably require.
- **21.6.3** Accord fair and equal treatment with respect to any opportunity for discussions and revisions of proposals. Such revisions may be permitted after submission of proposals and prior to award.
- **21.6.4** Negotiate any modifications to a proposal that it deems acceptable, waive minor irregularities in the procedures, and reject any and all proposals.

- **21.6.5** Process the selection of the successful Proposer without further discussion.
- **21.6.6** Waive any irregularity in any proposal, or reject any and all proposals, should it be deemed in its best interest to do so. The City shall be the sole judge of Proposers' qualifications and reserves the right to verify all information submitted by the Proposers. The proposal selected will be that proposal which is judged to be the most beneficial to the City.
- **21.7 Financial Statements.** The City Representative reserves the right to request that Proposers submit their annual financial statements for the last three fiscal years, including company financial statement summaries, certified by a Certified Public Accountant. If the organization has been in business for a period of less than three years, Proposers may be required to submit a detailed business plan in addition to any pertinent information that would allow the City to evaluate the sufficiency of financial resources and the ability of the business to successfully perform the services enumerated in the contract. Unless otherwise stated, such requests would be made after the submission of the proposals and prior to award of a contract.

22. ADDITIONAL CONTRACT TERMS

22.1 Basis of Award. A contract will be awarded to the most responsible and responsive Proposer whose proposal meets the needs of the City to the best degree. **OFFICIAL AWARD WILL BE MADE BY CITY OF TAMPA PURCHASE ORDER ONLY.**

Prior to award resulting from this solicitation, the Successful Proposer shall be registered to transact business in the State of Florida and shall furnish the City with proof of registration with ten days of the notice to do so by the City. Failure to promptly submit this evidence of qualification to transact business in the State of Florida may be a basis for rejection of the proposal.

Any Proposer who is owing to the City of Tampa upon any debt, contract, or other obligation to the City, or who is a defaulter as a surety or otherwise, will not be eligible for consideration for contract award regarding this solicitation.

- **22.2 Contract Term.** The period of the contract shall be for three years from the effective date of the award, and may, by mutual written agreement, be renewed at the same terms and conditions for two additional one-year periods.
- **22.2.1 Supplemental Unilateral Renewal Periods.** The City, through its Director of Purchasing, has the option and reserves the right to unilaterally extend the original contract term or any renewal term for up to three (3) additional thirty (30) day periods, at the same terms and conditions. Notice of the City's intent to renew shall be provided by the City in writing to the Successful Proposer prior to the expiration of the contract, or the renewal period if the contract has been previously renewed.
- **22.3 Non-Appropriation of Funds**. In the event no funds or insufficient funds are appropriated for expenditures under this award, the City will notify the Successful Proposal in writing of such occurrence and the award shall terminate without penalty or expense to the City on the last day of the fiscal year in which sufficient funds have been appropriated.
- **22.4 Contract Termination.** When deemed to be in the best interest of the City, the City may cancel any award resulting from this specification by the following means:
 - 10-day written notice with cause; or
 - 30-day written notice without cause.
- **22.5 Addition/Deletion.** The City reserves the right to add to or delete any service/item from this proposal or resulting agreements when deemed to be in the best interest of the City.
- **22.6 Proposal Prices.** Prices quoted in the proposal shall include any and all shipping costs, shipped F.O.B. Tampa, FL, or to the facility location specified by the requestor or the purchase order.

All taxes of any kind and character payable on account of the work done and materials furnished under the contract shall be paid by the Successful Proposer and shall be deemed to be included in the proposal. The laws of the State of Florida provide that sales tax and use taxes are payable by the Successful Proposer upon the tangible personal property incorporated

in the work and such taxes shall be paid by the Successful Proposer and shall be deemed to have been included in the proposal. The City is exempt from all State and Federal sales, use and transportation taxes.

Proposal prices include all royalties and costs arising from patents, trademarks, and copyrights in any way involved in the work. Whenever the Successful Proposer is required or desires to use any design, device, material or process covered by letters of patent or copyright, the Successful Proposer shall indemnify, defend and save harmless the City, its officers, agents and employees from any and all claims for infringement by reason of the use of any such patented design, tool, material, equipment, or process, to be performed under the contract, and shall indemnify the said City, its officers, agents, and employees for any costs, expenses and damages which may be incurred by reason of any infringement at any time during the prosecution or after the completion of the work. The duty to defend under this paragraph is independent and separate from the duty to indemnify, and the duty to defend exists regardless of any ultimate liability of the Successful Proposal, the City, and any indemnified party. This provision shall survive the termination of this contract and shall continue in full force and effect so long as the possibility of any liability, claim or loss exists, unless otherwise prohibited by law.

22.7 Government Purchasing Council. Hillsborough County Government Purchasing Council ("GPC") members, may, at their discretion or option, utilize this proposal as they require. Estimated quantities for Hillsborough County GPC members have not been included in the solicitation. Purchases by these entities may increase the value of the award. A list of the members of the GPC is contained within this solicitation document.

Any Hillsborough County GPC member which avails itself of this contract will establish its own contract, place its own orders, issue its own purchase orders, and issue its own exemption certificates as required by the Proposer. It is understood and agreed that the City of Tampa is not a legally bound party to any contractual agreement made between any other governmental entity and the Successful Proposer as a result of this RFP.

22.8 Use of Contract by Other Governmental Agencies. Unless otherwise stipulated by the Successful Proposer in its proposal, the Successful Proposer agrees to make available to all government agencies, departments, and municipalities the proposed prices submitted in accordance with the terms and conditions of this Solicitation Document, should any governmental entity desire to buy under the Contract resulting from this Solicitation Document.

Any other governmental agency, department, or municipality which avails itself of this contract will establish its own contract, place its own orders, issue its own purchase orders, and issue its own exemption certificates as required by the Proposer. It is understood and agreed that the City of Tampa is not a legally bound party to any contractual agreement made between any other governmental entity and the Proposer as a result of this solicitation.

- **22.9 Use of State Contract, GPC, Or Cooperative Purchasing Bids.** The City of Tampa reserves the right to utilize applicable State of Florida Contracts, GPC Bids, or those contracts of any other federal, state, or local governmental entity under the terms of a bid submitted to such entity, provided that such contract is procured in compliance with the procuring entity's law, bylaws, regulations, or ordinances regarding competitive solicitation, which must provide for full and open competition for any items covered by this specification when the use of same is in the best interest of the City of Tampa.
- **22.10 Payment.** Full payment will be made by the City after receipt and acceptance of materials/services and proper invoice in accordance with Florida Statutes § 218.70, et. seq., the Florida's Local Government Prompt Payment Act. Proposers that accept Visa/Mastercard payments can be enrolled in the City's ePayments program for faster payment turnaround, by contacting the City's Accounts Payable Department at acctspayable@tampagov.net.
- **22.11 Minimum Wage Amendment.** The Successful Proposer shall comply with the minimum wage requirements as required in Article X, Section 24, Constitution of the State of Florida.

The rate of wages for all persons employed by the Successful Proposer on the work covered shall not be less than the rate of wages required by the Fair Labor Standards Act (Public Law 104-188).

- **22.12 Invoicing.** The Successful Proposer shall furnish the City complete itemized invoices for work performed. Invoices are to reflect the prices stipulated on the purchase order and as outlined in this proposal itemizing parts, labor hours, materials, etc. The City will not accept an aggregate invoice. As part of the award process, the City may request a sample invoice. Invoices shall contain, but not be limited to the following information:
 - Invoice number;
 - Company Name;
 - City work order number (if applicable);

- Purchase order number;
- Location and dates of work;
- Cost of work as stated on Pricing/Proposal pages and extended price to reflect total cost.

However, the City shall continue to be liable for the obligations it incurred under this contract prior to the effective date of the assignment. Action by the City in awarding a proposal to a proposer, which has disclosed its intent to assign or subcontract in its response to the RFP, without exception shall constitute approval for purposes of this contract.

In the event of such approved Sub-Contracting, the Successful Proposer agrees to provide the City with written documentation relative to the Subcontractor(s) solicited, or that will be employed in this contract, including but not limited to submittal of attached Schedule of Sub-Contracting forms, with the proposal response.

specification on the open market; or (ii) make an award to the next best Proposer and establish the period of such contract, provided such period is no longer than the contract period set forth in this specification.

22.16 Convicted Vendor List (Public Entity Crime). EXHIBIT 1 - CITY OF TAMPA INSURANCE REQUIREMENTS

Prior to commencing any work or services or taking occupancy under that certain written agreement or award (for purposes of this document, Agreement) between the City of Tampa, Florida (City) and Firm/Awardee/Successful Proposer/Contractor/Consultant/Lessee/non-City party, etc. (for purposes of this document, Firm) to which this document is attached and incorporated as an Exhibit or otherwise, and continuing during the term of said Agreement (or longer if the Agreement and/or this document so requires), Firm shall provide, pay for, and maintain insurance against claims which may arise from or in connection with the performance of the Agreement (including without limitation occupancy and/or use of certain property/premises) by Firm, its agents, representatives, employees, suppliers, subtenants, or subcontractors (which term includes sub-consultants, as applicable) of any tier subject to the terms and conditions of this document. Should at any time Firm not maintain the insurance coverages required, City at its sole option (but without any obligation or waiver of its rights) may terminate the Agreement. All provisions intended to survive or to be performed subsequent to the expiration or termination of the Agreement shall survive, including without limitation Firm's obligation to maintain or renew coverage, provide evidence of coverage and certified copies of policies, etc. upon City's request and/or in response to a potential claim, litigation, etc.

The following coverages are required: ("M" indicates million(s), for example \$1M is \$1,000,000)

- A. <u>Commercial General Liability (CGL) Insurance</u> on the most current Insurance Services Office (ISO) Form CG 00 01 or its equivalent on an "occurrence" basis (Modified Occurrence or Claims Made forms are not acceptable without prior written consent of the City). Coverage must be provided to cover liability contemplated by the Agreement including without limitation premises and operations, independent contractors, contractual liability, products and completed operations, property damage, bodily, personal, and advertising injury, contractual liability, explosion, collapse, underground coverages, personal injury liability, death, employees-as-insureds. Products and completed operations liability coverage maintained for at least 3 years after completion of work. **Limits shall not be less than \$1M per occurrence and \$2M general aggregate for Agreements valued at \$2M or less; if valued over \$2M, a general aggregate limit that equals or exceeds the Agreement's value.** If a general aggregate limit applies, it shall apply separately to the project/location (ISO CG 25 03 or 25 04 or equivalent).
- **B.** <u>Automobile Liability (AL) Insurance</u> in accordance with Florida law, as to the ownership, maintenance, and use of all owned, non-owned, leased, or hired vehicles. **AL insurance shall not be less than: (a) \$500,000** combined single limit each occurrence bodily injury and property damage for Agreements valued at \$100,000 or less or (b) \$1M combined single limit each occurrence bodily injury and property damage for Agreements valued over \$100,000. If transportation of hazardous material involved, the MCS-90 endorsement (or equivalent).
- C. <u>Worker's Compensation (WC) & Employer's Liability Insurance</u> for all employees engaged under the Agreement, Worker's Compensation as required by Florida law. **Employer's Liability with minimum limits of (a)** \$500,000 bodily injury by accident and each accident, bodily injury by disease policy limit, and bodily injury by disease each employee for Agreements valued at \$100,000 and under or (b) \$1M bodily injury by accident and each accident, bodily injury by disease policy limit, and bodily injury by disease each for all other Agreements.
- **D.** <u>Excess (Umbrella) Liability Insurance</u> for Agreements valued at \$2M or more, at least \$4M per occurrence in excess of underlying limits and no more restrictive than underlying coverage for all work performed by Firm. May also compensate for a deficiency in CGL, AL, or WC.

Firm affirmatively states that the insurance requirements as set forth above are of adequate types and amounts of insurance coverage for any type of claim/loss for the proposed work or services.

ACCEPTABILITY OF INSURERS - Insurance is to be placed with insurers admitted in the State of Florida and who have a current A.M. Best rating of no less than **A-:VII** or, if not rated by A.M. Best, as otherwise approved by the City in advance and in writing.

ADDITIONAL INSURED - City, its elected officials, departments, officers, officials, and employees shall be covered as additional insureds on all liability coverage (e.g., CGL, AL, and Excess (Umbrella) Liability) as to liability arising out of work or operations performed by or on behalf of Firm including materials, parts, or equipment furnished in connection with such work or operations and automobiles owned, leased, hired, or borrowed by or on behalf of Firm. Coverage can be provided in the form of an endorsement to Firm's insurance (at least as broad as ISO Form CG 20 10 11 85 or **both** CG 10 20, CG 20 26, CG 20 33, or CG 20 38 **and** CG 20 37 if later revisions used).

<u>CANCELLATION/NON-RENEWAL</u> – Each insurance policy shall provide that at least 30 days written notice must be given to City of any cancellation, intent to non-renew, or material reduction in coverage (except aggregate liability limits) and at least 10 days' notice for non-payment of premium. Firm shall also have an independent duty to notify City in like manner, within 5 business days of Firm's receipt from its insurer of any notices of same. If any policy's aggregate limit is reduced, Firm shall directly take steps to have it reinstated. Notice and proof of renewal/continued coverage/certifications, etc. shall be sent to the City's notice (or Award contact) address as stated in the Agreement with a copy to the following:

- (2) Other: City of Tampa Insurance Compliance c/o Ebix BPO, PO Box 100085- ZS, Duluth, GA 30096

<u>CERTIFICATE OF INSURANCE (COI) AND ENDORSEMENTS</u> – to be provided to City by insurance carrier prior to Firm beginning any work/services or taking occupancy and, if the insurance expires prior to completion of the work or services or Agreement term (as may be extended), a renewal COI at least 30 days before expiration to the above address(es). COIs shall specifically identify the Agreement and its subject (project, lease, etc.), shall be sufficiently comprehensive to ensure City (named as additional insured) and Firm and to certify that coverage extends to subcontractors' acts or omissions, and as to permit the City to determine the required coverages are in place without the responsibility of examining individual policies. **Certificate Holder must be The City of Tampa, Florida**.

<u>CLAIMS MADE</u> — If any liability insurance is issued on a claims made form, Firm agrees to maintain such coverage uninterrupted for at least 3 years following completion and acceptance of the work either through purchase of an extended reporting provision or purchase of successive renewals. The Retroactive Date must be shown and be a date not later than the earlier of the Agreement date or the date performance/occupancy began thereunder.

DEDUCTIBLES/ SELF-INSURED RETENTIONS (SIR) – must be disclosed to City and, if over \$500,000, approved by the City in advance and in writing, including at City's option being guaranteed, reduced, or eliminated (additionally if an SIR provides a financial guarantee guaranteeing payment of losses and related investigations, claim administration, and defense expenses). Firm shall be fully responsible for any deductible or SIR (without limiting the foregoing a policy with an SIR shall provide or be endorsed to provide that the SIR may be satisfied by either the City or named insured). In the event of loss which would have been covered but for a deductible or SIR, City may withhold from any payment due Firm, under any agreement with the City, an amount equal to same to cover such loss should full recovery not be obtained under the policy.

PERFORMANCE – All insurance policies shall be fully performable in Hillsborough County, Florida (the County), and construed in accordance with Florida law. Further, all insurance policies must expressly state that the insurance company will accept service of process in the County and that the exclusive venue for any action concerning any matter under those policies shall be in the appropriate state court of the County.

PRIMARY POLICIES - Firm's insurance coverage shall be primary insurance coverage at least as broad as ISO CG 20 01 04 13 as to the City, its elected officials, departments, officers, and employees. Any insurance or self-insurance maintained by the City, its elected officials, departments, officers, and employees shall be excess of the Firm's insurance and shall not contribute with it.

UNAVAILABILITY – To the fullest extent permitted by law, if Firm is out of business or otherwise unavailable at the time a claim is presented to City, Firm hereby assigns to the City all of its right, title, and interest (but not any liabilities or obligations) under any applicable policies of insurance.

<u>WAIVER OF SUBROGATION</u> – With regard to any policy of insurance that would pay third party losses, Firm hereby grants City a waiver of any right to subrogation which any insurer of Firm may acquire against the City by virtue of the payment of any loss under such insurance. Firm agrees to obtain any endorsement that may be necessary to affect such waiver, but this provision shall apply to such policies regardless.

ADDITIONAL COVERAGES TO BE ADDED TO REQUIERED INSURANCE COVERAGES FOR PURCHASING AWARDS/CONTRACTS ON A CASE-BY-CASE BASIS

- **E.** Architects & Engineers Liability / Professional Liability (E&O) / Contractors Professional Liability (CPrL) / Medical Malpractice Insurance where Agreement involves Florida-regulated professional services (e.g. architect, engineer, design-builder, CM, accountant, appraiser, investment banker medical professional) at any tier, whether employed or independent, vicarious design liability exposure (e.g. construction means & methods, design supervision), value engineering, constructability assessments/reviews, BIM process, and/or performance specifications. Limits of at least \$1,000,000; deletion of design/ build liability exclusions, as applicable, and maintained for at least 3 years after completion of work/services and City's acceptance of same.
- **Cyber Liability Insurance** where Agreement involves portals allowing access to obtain, use, or store data; managed dedicated servers; cloud hosting services; software/hardware; programming; and/or other IT services and products are involved. Limits of not less than \$2M per occurrence and \$2M aggregate. Coverage sufficiently broad to respond to duties and obligations undertaken by Firm, and shall include, but not be limited to, claims involving infringement of intellectual property/copyright, trademark, trade dress, invasion of privacy violations, damage to or destruction of electronic information, information theft, release of confidential and/or private information, alteration of electronic information, extortion, virus transmission, and network security. Coverage, as applicable and with sufficient limits to respond, for breach response costs, regulatory fines and penalties, credit monitoring expenses.
