A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE REQUEST FOR PROPOSALS PROCESS AND ADOPTING THE COMPETITIVELY BID TERMS BETWEEN THE CITY OF HALLANDALE BEACH AND AWARE DIGITAL, INC. FOR THE PROVISION OF INSTALLATION OF A SECURITY CAMERA SYSTEM AT DORAL MEADOW PARK AND MORGAN LEVY PARK IN AN AMOUNT NOT TO EXCEED \$125,000.00; DIRECTING THE CITY MANAGER AND THE CITY ATTORNEY TO NEGOTIATE A CONTRACT WITH AWARE DIGITAL INC. ON THE BASIS OF SAID TERMS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City has evaluated the security needs at Doral Meadow Park and Morgan Levy Park; and

WHEREAS, Staff recently received a demonstration of the needed security equipment by Aware Digital, Inc. (Aware) which will enhance safety efforts and aid in the prosecution of offenders; and

WHEREAS, Aware has undergone the competitive procurement process in the City of Hallandale Beach and has since entered into "piggyback" agreements with other local government agencies; and

WHEREAS, Staff respectfully recommends that the City Council waive the Request for Proposals (RFP) process and adopt the competitively bid terms between the City of Hallandale Beach and Aware for the provision of installation of a security camera system at Doral Meadow Park and Morgan Levy Park in an amount not to exceed \$125,000.00; and

WHEREAS, Staff further recommends that the City Council direct the City Manager and the City Attorney to negotiate a contract with Aware on the basis of said terms.

Section 1. The City Council of the City of Doral hereby waives the RFP process

and adopts the competitively bid terms between the City of Hallandale Beach and Aware

for the provision of installation of a security camera system at Doral Meadow Park and

Morgan Levy Park in an amount not to exceed \$125,000.00.

Section 2. The City Council further directs the City Manager and the City Attorney

to negotiate a contract with Aware on the basis of said terms.
