

**RESOLUTION No. 19-248**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN OUTDOOR EVENT PERMIT FOR RACETIME LLC, TO HOST THE “DORAL CORPORATE RUN 2019” AT THE NW 25 STREET INDUSTRIAL PARK LOCATED AT 10000 NW 25 STREET, DORAL, FL 33172; TO TAKE PLACE ON THURSDAY DECEMBER 5, 2019 FROM 6PM-9PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the RaceTime, LLC, (the “Applicant”) seeks approval from the City of Doral for an Outdoor Event Permit; and

**WHEREAS**, staff recommends Council to approve the proposed Outdoor Event Permit to host the “Doral Corporate Run 2019” event on Thursday, December 5, 2019 at 25th Street Industrial Park, located at 10000 NW 25th street, Doral, Florida 33172, from 6pm-9pm.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval.** The outdoor event permit for the “Doral Corporate Run 2019” is hereby approved subject to the following conditions:

1. Applicant shall comply with the comments made by the City of Doral Police Department prior to the event start date.
2. All building permits and inspections required by the Building Department shall be completed prior to the event start date.
3. Applicant shall provide a current certificate of insurance prior to the event start date.
4. Applicant is responsible to pay all outstanding city fees prior to the issuance of the Outdoor Events Permit.

5. Applicant shall provide courtesy notice of the event to all businesses affected by the road closures at least five days prior to the event. Such notice shall be provided to the Planning and Zoning Department at least three days prior to transmitting the courtesy notices to the businesses affected by the road closures.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Cabrera who moved its adoption. The motion was seconded by Councilmember Cabral and upon being put to a vote, the vote was as follows:
