

**RESOLUTION NO. 14- 88**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING AN EXTENSION TO THE FARMERS' MARKET PERMIT FOR DORAL CENTRE ASSOCIATES, LTD., TO BE HELD AT 9525 NW 41<sup>ST</sup> STREET, DORAL, FLORIDA ON SUNDAY'S FROM JUNE 15, 2014 TO SEPTEMBER 28<sup>TH</sup>, 2014 BETWEEN THE HOURS OF 10:00 A.M. TO 4:00 P.M.; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS;** Doral Centre Associates LTD ("Applicants") seek approval to from the City of Doral to extend the Farmers' Market at Doral Center; and

**WHEREAS,** Staff respectfully recommends that Council approve the proposed Farmers' Market for to be held at Doral Center located at 9525 NW 41<sup>st</sup> Street Doral, Florida, on Sunday's from June 15, 2014 to September 28, 2014 from 10:00 am to 4:00 pm, subject to the following conditions:


1. Construction plans for tents (larger than 10 X 10) and any structural facility must be submitted to the Building Department for approval.
2. Applicant shall obtain electrical permit for generators if required by the Building Department.
3. All City and State Licenses must be obtained prior to the opening of the Market.
4. All trash and refuse must be removed from the site at the end of each day.
5. Lighting must be provided during morning set up prior to sunrise if applicable.
6. Furnish an updated Certificate of Liability Insurance, with the City as the certificate holder, prior to the current certificate's expiration dated August 18, 2014.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral, Florida hereby approves the extension of the farmers' market permit for Doral Centre Associates LTD ("Applicants") to be held at Doral Center located at 9525 NW 41<sup>st</sup> Street Doral, Florida, on 9525 NW 41<sup>st</sup> Street Doral, Florida, on Sunday's from June 15, 2014 to September 28, 2014 from 10:00 am to 4:00 pm, subject to the conditions listed in the above "whereas" clause.
