A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND ADA ENGINEERING, A PREQUALIFIED VENDOR. **FOR** THE **PROVISION** CONSTRUCTION ENGINEERING INSPECTION SERVICES FOR THE STORMWATER IMPROVEMENTS PROJECT AT SUB BASINS F-5, C-6, C-7, & G-1 OF THE STORMWATER MASTER PLAN UPDATE, IN AN AMOUNT NOT TO EXCEED \$31,616.56: AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") wishes to secure a firm to provide Construction Engineering Inspection services for the construction of stormwater improvements at Sub Basins F-5, C-6, C-7, & G-1 of the Stormwater Master Plan Update ("CEI Services"); and

WHEREAS, ADA Engineering ("ADA"), a prequalified vendor, is a professional engineering services firm that was selected in accordance with Consultant Competitive Negotiation Act requirements and approved by the City Council in December 2014; and

WHEREAS, City Staff has recommended that the City Council approve Work Order No. 6 for ADA Engineering, a copy of which is attached hereto as Exhibit "A", for the provision of CEI services in an amount not to exceed \$31,616.56.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** Work Order No. 6 for CEI services for the construction of stormwater improvements at Sub Basin H-5 of the Stormwater Master Plan Update, in an

amount not to exceed \$31,616.56, a copy of which is attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved. The City Manager is authorized to execute the Work Order and expend budgeted funds on behalf of the City.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.

This Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 2, 2015 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.
