

RESOLUTION No. 24-256

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE CO-DESIGNATION OF NW 85 AVENUE FROM NW 52 STREET TO NW 46 STREET AS “PASEO BOULEVARD”; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, NW 85th Avenue from NW 53rd Terrace to NW 52nd Street is currently named Paseo Boulevard as part of the Downtown Doral development; and

WHEREAS, the southern portion of NW 85th Avenue, from NW 52nd Street to approximately NW 46th Street, was constructed as part of the Downtown Doral South development process and did not continue with the Paseo Boulevard name, but instead remained named NW 85th Avenue; and

WHEREAS, the adjacent property owners along the southern portion of the roadway made a request to the City to rename the roadway as “Paseo Boulevard”; and

WHEREAS, as a result of this request, City staff forwarded the request to Codina which resulted in the installation of the street name signs naming NW 85th Avenue as Paseo Boulevard along this “southern” portion; and

WHEREAS, the signs were installed a couple of years ago, but a formal co-designation application was never submitted to Miami-Dade County; and

WHEREAS, in order for the County to process our co-designation application, it is necessary that the City Council adopt a resolution in favor of the co-designation; and

WHEREAS, the co-designation of the street will ensure that U.S. Postal Mail and other carrier services are able to accurately locate residents that reside along Paseo Boulevard; and

WHEREAS, Ordinance No. 2008-15 establishes an official process for naming, re-naming and/or co-designating a City street; and

WHEREAS, in light of the action taken by City Staff and Codina Partners, portion of NW 85th Avenue contain signage that reflects the name “Paseo Boulevard,” rendering Ordinance No. 2008-15 moot; and

WHEREAS, the Public Works Department is desirous of an official co-designation of portion of NW 85th Avenue to “Paseo Boulevard” in order to provide for continuity of the Paseo Boulevard name; and

WHEREAS, the City Council finds that the co-designation of portions of 85th Avenue to “Paseo Boulevard,” is in the best interest of the City and its residents.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The co-designation of NW 85th Avenue between NW 52nd Street and approximately NW 46th Street as “Paseo Boulevard” is hereby approved.

Section 3. Authorization. The City Manager is authorized to approve the co-designation application of behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Puig-Corve who moved its adoption.


