

RESOLUTION No. 24-263

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE CO-DESIGNATION OF NW 53 TERRACE FROM NW 87 AVENUE TO NW 53 STREET AS “UHEALTH WAY”; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral adopted Ordinance 2008-15 and established a policy for the naming, re-naming and/or co-designating a City street; and

WHEREAS, the City of Doral received an application for the co-designation of NW 53rd Terrace from NW 87th Avenue and NW 53rd Street as “UHealth Way”; and

WHEREAS, the City of Doral Public Works Department has evaluated the application and verified that all the Ordinance requirements have been satisfied; and

WHEREAS, the application is being sponsored by the office of the Mayor; and

WHEREAS, city Staff respectfully request that the Mayor and the City Councilmembers approve the co-designation of NW 53rd Terrace between NW 87th Avenue and NW 53rd Street as “UHealth Way”; and

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The application for the co-designation of NW 53rd Terrace between NW 87th Avenue and NW 53rd Street as “UHealth Way”, a copy of the application which is attached hereto as Exhibit “A”.

Section 3. Authorization. The City Manager is authorized to approve the co-designation application of behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
