SCOPE OF SERVICES AND SCHEDULE:

In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply.

Work Order is not binding until the City of Doral agrees and approves this Work Order.



F.R. Aleman and Associates, Inc (FRA) proposes to provide the Traffic Data Collection services for Seven (7) days Continuous Speed Counts identified at NW 115 Court between NW 82 Street and NW 84 Terrace.

I. GENERAL

Pursuant to the Scope of Work of the Professional Service Agreement, FRA shall provide Traffic Data Collection Services, continuous speed counts to be collected for Seven (7) days at NW 115 Court between NW 82 Street and NW 84 Terrace.

II. SCOPE OF WORK
