

RESOLUTION No. 06 – 72

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, DECLARING THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 7TH, 2006; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, a General Election has been held in the City of Doral, Florida in accordance with the law on November 7th, 2006 for the purpose of electing a Councilmember for Seat 2 and Seat 4; and

WHEREAS, the Miami-Dade County Canvassing Board has canvassed the votes cast in said General Election.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida finds, after canvass of the votes cast in the General Election held on November 7th, 2006 that the results, contingent upon certification, are as follows:

Section 2. The City Council of the City of Doral, Florida hereby declares that SANDRA RUIZ has been elected in accordance with the laws of the State of Florida and the Charter of the City of Doral to City Council Seat 2 commencing November 8th, 2006 after having obtained the highest number of votes cast in the General Election on November 7th, 2006.

Section 3. The City Council of the City of Doral, Florida hereby declares that ROBERT VAN NAME has been elected in accordance with the laws of the State of Florida and the Charter of the City of Doral to City Council Seat 4 commencing on November 8th, 2006 after having been unopposed in the November 7th, 2006 General Election.

Section 4. In the event that any portion of this Resolution found to be illegal, it shall be severed herefrom without affecting the validity or enforceability of the remaining portion of this resolution.

Section 5. All Resolutions or part of Resolutions in conflict herewith are hereby repealed to the extent of such conflict.

Section 6. This Resolution shall take effect immediately upon adoption.
