A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN AGREEMENT WITH DELL INC. FOR CONSULTING SERVICES TO PROVIDE A HEALTH CHECK OF, AND IMPLEMENT HIGH RISK SOLUTIONS TO, THE CITY'S VIRTUAL SERVER ENVIRONMENT IN THE AMOUNT OF \$20,000.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT AND TO EXPEND FUNDS FROM THE CITY'S CONTINGENT RESERVES; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on July 21, 2015, the City of Doral (the "City") experienced an overutilization of system resources on its Virtualized Infrastructure ("VI"); and

WHEREAS, this systemic anomaly caused the infrastructure to begin a rebalancing of resources across the Virtual Machine (VM) environment and caused several systems to fail, including Active Directory, DNS Services, Microsoft Exchange Email Services, and Web Services for the City Web site as well as Exchange Web Services such as: Cashiering Web service, COD Main Menu, Crywolf, Business Tax renewal, Parks and the Lien application; and

WHEREAS, staff has recommended that an emergency risk assessment be performed on the VI and, as a result, modifications be made to the VI, so as to avoid such disruption in the future; and

WHEREAS, given the type of equipment and software being used and run by the City, staff has recommended contracting with Dell, Inc. for urgent consulting services to provide a health check of, and implement high risk solutions to, the City's virtual server environment, in the amount of \$20,000.00.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> Approval. An agreement with Dell, Inc. for urgent consulting services to provide a health check of, and implement high risk solutions to, the City's virtual server environment, in the amount of \$20,000.00 is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is hereby authorized to execute such agreements and other contractual documents, subject to approval by the City Attorney as to form and legal sufficiency, as may be necessary to consummate the procurement of the good and services contemplated herein. The City Manager is authorized to expend funds from the City's contingent reserves in furtherance hereof.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
