A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH ILER PLANNING TO PROVIDE PROFESSIONAL PLANNING SERVICES RELATED TO THE RE-EVALUATION OF THE CITY'S COMPREHENSIVE PLAN UPDATE PHASE II IN AN AMOUNT NOT TO EXCEED \$25,000.00; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, due to the growth in population and residential and non-residential developments in the past several years the City of Doral decided to update its Comprehensive Plan; and

WHEREAS, the City's Comprehensive Plan Update Phase I was approved by Council on January 13, 2015 by Resolution No. 15-07; and

WHEREAS, the City's Comprehensive Plan Update Phase II was budgeted and adopted on September 23, 2015 by Ordinance No. 2015-37; and

WHEREAS, the Iler Planning has been intimately involved in the City's planning efforts since the City's inception and most specifically with the Comprehensive Plan, Green Master Plan, and updates to the Capital Improvement Element; and

WHEREAS, Iler Planning, Inc. was selected to assist the City update the 2016 City's Comprehensive Plan; and

WHEREAS, it is proposed that said update will include revision to several elements of the Comprehensive Plan, including the goals, objectives and policies; update of the Data, Inventory and Analysis (DIA) to incorporate new information into the plan; and

WHEREAS, section 2-323 of the City Code exempts contracts for professional services from competitive bidding; and

WHEREAS, staff has recommended that the City Council authorize the City Manager to negotiate and enter into an agreement with Iler Planning for the Phase II of the 2016 Comprehensive Plan Update.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing recital is confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Authorization. Pursuant to section 2-323 of the City Code of Ordinances, the City Manager is hereby authorized to negotiate and enter into an agreement with Iler Planning for provision of professional planning services to update the 2016 Comprehensive Plan in an amount not to exceed \$25,000, and to expend budgeted funds in furtherance hereof.

<u>Section 3</u>. <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
