## **RESOLUTION No.12-40**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING AN OUTDOOR EVENT PERMIT FOR RODOMAR INC TO PERMIT THE "HOUSE OF HORROR" EVENT TO TAKE PLACE WITHIN THE PARKING LOT OF MIAMI INTERNATIONAL MALL FROM SEPTEMBER 27, 2012 TO OCTOBER 31<sup>ST</sup>, 2012 FROM 6:00 PM TO MIDNIGHT MONDAY THROUGH FRIDAY AND 5:00 PM TO MIDNIGHT ON SATURDAY AND SUNDAY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS; Rodomar Inc., ("Applicants") seeks approval from the City of Doral for an Outdoor Event Permit; and

WHEREAS, Staff respectfully recommends that Council approve the proposed Outdoor Event Permit for the "House of Horror" event to be held from September 27, 2012 through October 31<sup>st</sup>, 2012 from 6:00 pm to midnight Monday through Friday and 5:00 pm to midnight on Saturday and Sunday within the parking lot at Miami International Mall with the following conditions:

- I. An agreement with the City of Doral Police must be established for off-duty security prior to the event.
- 2. All of the requirements as established by the City of Doral Police Department must be met at time of event.
- 3. All building permits must be obtained prior to the event.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

- **Section 1.** The foregoing recitals are incorporated herein.
- **Section 2**. The City Council of the City of Doral, Florida hereby approves the

outdoor event permit for Rodomar Inc., "House of Horror" event subject to the conditions listed in the above "whereas" clause.

Section 3. This Resolution shall take effect immediately upon adoption.
