
SCOPE OF SERVICES AND SCHEDULE:



RESOLUTION No. 20-11

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND MARLIN ENGINEERING, INC., TO PROCEED WITH PROFESSIONAL ENGINEERING SERVICES FOR THE HYDROLOGICAL ANALYSIS FOR DORAL LEGACY PARK IN AN AMOUNT NOT TO EXCEED \$27,062.48; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral opened Doral Legacy Park on September 18th, 2017;
and

WHEREAS, after construction was completed and the park was opened and operational it was noticed that certain areas of the park experienced excessive ponding during rain events; and

WHEREAS, the Public Works Department has requested a proposal from Marlin Engineering, Inc. (Marlin) for the provision of a hydrological analysis of the Park that would address the areas of excess ponding; and

WHEREAS, Marlin, is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

WHEREAS, City staff respectfully requests that the Mayor and City Council members approve Work Order No. 18 for Marlin, a copy of which is attached hereto as Exhibit "A", for the provision of professional engineering services that include the hydrological analysis of Doral Legacy Park, on a time and material basis in an amount not to exceed \$27,062.48,
and

WHEREAS, funds for these services will be allocated from the Public Works General Fund in Fiscal Year 2019-20 in account number 001.8000500.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Work Order between the City of Doral and Marlin Engineering, Inc. for the professional engineering services for the hydrological analysis of Doral Legacy Park, in an amount not to exceed of \$27,062.48, a copy which is attached as Exhibit "A", is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the Work Order and expend budgeted funds on behalf of the City in furtherance hereof.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
