A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY MIAMI CITY BALLET/ CODINA PARTNERS TO HOST "THE NUTCRACKER BALLET" TO BE HELD AT DOWNTOWN DORAL PARK, LOCATED AT 8395 NW 53 STREET, DORAL, FL 33166 BETWEEN THE DAYS OF FRIDAY, DECEMBER 11, 2020 THRU THURSDAY, DECEMBER 31, 2020; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Miami City Ballet/ Codina Partners (the "Applicant") seeks approval from the City of Doral for a Special Event Permit to host the "The Nutcracker Ballet" in the City of Doral; and

WHEREAS, staff recommends that the Mayor & City Council approve the proposed Special Event Permit to host the "The Nutcracker Ballet" on Friday, December 11th, 2020 to Thursday, December 31st, 2020 at Downtown Doral Park, located at 8395 NW 53rd Street, Doral, FL 33166.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> The above recitals are true and correct and incorporated herein.

Section 2. Approval. The special event permit for the "The Nutcracker" is hereby approved subject to the following conditions:

- 1. Applicant shall coordinate and comply with the comments made by the City of Doral Police Department after the adoption of this Resolution.
- 2. All building permits and inspections required by the Building Department shall be completed prior to the event start date.
- 3. The applicant shall coordinate and comply with any comments by the City of Doral Parks Department and

- 4. The City is hereby waiwing all fees for the event
- 5. The City is hereby sponsoring the costs associated with the event.
- 6. Applicant shall allocate tickets to residents equivalent to one show (estimated at 150 pods) at a cost of \$50 per pod.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
