The City of Doral authorizes the firm of EAC Consulting Inc. to provide professional engineering services for the provision of post-design services during the construction of NW 41 Street between NW 79 Avenue and NW 87 Avenue. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between EAC Consulting Inc. and the City of Doral dated February 26, 2018, and the attached Proposal submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCHEDULE:

The scope of the project will be as described in the attached proposal from EAC Consulting Inc. dated November 26, 2019 for the post-design services during the construction of the roadway improvements along NW 41 Street (79-87 Avenue). The schedule requires the scope of work to be completed within 10 months of Notice to Proceed. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a Time and Materials basis with a not to exceed amount of \$23,000.00.


You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 26, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the day and date first above written, in three (3) counterparts, each of which shall, without proof or accounting for the other counterpart be deemed an original Contract.

RESOLUTION No. 19-313

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND EAC CONSULTING, INC. FOR THE PROVISION OF POST DESIGN SERVICES DURING THE CONSTRUCTION OF ROADWAY IMPROVEMENTS ALONG NW 41 STREET BETWEEN NW 79 AVENUE AND NW 87 AVENUE, IN AN AMOUNT NOT TO EXCEED \$23,000.00; RECOGNIZING THAT EAC CONSULTING, INC. IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Public Works Department (PWD) wishes to secure a firm to provide Post Design services during the construction of roadway improvements along NW 41 Street between NW 79 Avenue and NW 87 Avenue; and

WHEREAS, the PWD requested a proposal from EAC Consulting, Inc. (EAC), for the provision of Post Design services for the construction of roadway improvements along NW 41 Street between NW 79 Avenue and NW 87 Avenue; and

WHEREAS, EAC is a pre-qualified provider (RFQ 2017-21) of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

WHEREAS, City staff respectfully requests that the Mayor and City Council members approve Work Order No. 9 for EAC, a copy of which is attached hereto as Exhibit "A", for the provision of Post Design services during the construction of roadway improvements along NW 41 Street between NW 79 Avenue and NW 87 Avenue on a time and material basis in an amount not to exceed \$23,000.00; and

WHEREAS, funding for this request is available from previous Fiscal Years in the Stormwater Fund Account No. 401.80005.500650, encumbered under Purchase Order

20192045 (\$30,000), which will cover \$10,000 of the total cost, and in the current Fiscal Year in the Transportation Fund Account No. 101.80005.500650 (Project/Construction Management/CEI), which will cover \$13,000 of the total cost.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Work Order No. 9 for Post Design services during the construction of roadway improvements along NW 41 Street between NW 79 Avenue and NW 87 Avenue, in an amount not to exceed \$23,000.00, a copy of which is attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the work order and expend budgeted funds on behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
