- 2. Construction plans for tents (larger than 10 X 10) and any structural facility must be submitted to the Building Department for approval.
- 3. Applicant shall obtain electrical permit for the generator.
- 4. Hours of Operation limited from 5:00 pm to 10:00 pm.
- Provide private security officers and retain the services of off-duty police officers for safety and traffic control as determined by the City of Doral Police Department.
