

**RESOLUTION No. 22-39**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY SHOMA GROUP TO HOST THE “GRAND OPENING OF SHOMA BAZAAR” AT 9420 NW 41 STREET ON THURSDAY, MARCH 10, 2022, FROM 7:30 PM TO 11:00 PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Shoma Group (the “Applicant”) seeks approval from the City of Doral of a special event permit to host the “Grand Opening of Shoma Bazaar” at 9420 NW 41 Street; and

**WHEREAS**, “Grand Opening of Shoma Bazaar” is an event to advertise and celebrate the opening of Shoma Bazaar; and

**WHEREAS**, staff recommends that the Mayor and City Council approve the proposed special event permit to host “Grand Opening of Shoma Bazaar,” Thursday, March 10, 2022, at Shoma Bazaar located at 9420 NW 41 Street, Doral from 7:30 p.m. to 11:00 p.m.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

**Section 2. Approval.** The special event permit for the “Grand Opening of Shoma Bazaar” is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
2. Applicant shall be required to have all inspections and approvals prior to the event date.

3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
5. Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees in advance of the event.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilmember Mariaca who moved its adoption. The motion was seconded by Vice Mayor Cabral and upon being put to a vote, the vote was as follows:
