

RESOLUTION No. 19-249

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN OUTDOOR EVENT PERMIT FOR RUNNERS AND COMPANY LLC, TO HOST THE “RUN XMAS 5K 2019” EVENT AT DORAL MEADOW PARK LOCATED AT 11555 NW 58 STREET, DORAL, FL 33178 ON SUNDAY, DECEMBER 1, 2019, FROM 7AM TO 10AM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Runner and Company, LLC (“Applicant”) seeks approval from the City of Doral for an Outdoor Event Permit; and

WHEREAS, staff recommends Council to approve the proposed Outdoor Event Permit to host the “Run Xmas 5K 2019” event on Sunday, December 1, 2019, located at Doral Meadow Park, 11555 NW 58th Street, Doral, FL 33178.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The outdoor event permit for the “Run Xmas 5K 2019” is hereby approved subject to the following conditions:

1. Applicant shall comply with the comments made by the City of Doral Police Department.
2. Applicant shall comply with the comments made by the City of Doral Parks and Recreation Department.
3. Applicant is responsible to pay all outstanding city fees prior to the issuance of the Outdoor Events Permit.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.
