

RESOLUTION No. 08 – 22

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO ADOPT THE COMPETITIVELY BID STATE OF FLORIDA CONTRACT WITH FLORIDA POLICE PRODUCTS, INC. FOR THE PROVISION OF UNIFORM ACCESSORIES FOR THE USE OF THE CITY OF DORAL, POLICE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$79,559.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral City Council seeks to meet the immediate equipment needs of the newly-formed City of Doral Police Department; and

WHEREAS, Florida Police Products, Inc. has a competitively bid contract with the State of Florida and has been a previous vendor for the City of Doral; and

WHEREAS, consistent with Section 12 – 10 of the City of Doral Purchasing Ordinance, Staff respectfully requests that Council authorize the City Manager to adopt the competitively bid State of Florida contract with Florida Police Products, Inc. for the provision of uniform accessories for the use of the City of Doral, Police Department in an amount not to exceed \$79,559.00 to allow the Police Department to begin operations in a timely matter.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby authorizes the City Manager to adopt the competitively bid State of Florida contract with Florida Police Products, Inc. for the provision of uniform accessories for the use of the City of Doral, Police Department in an amount not to exceed \$79,559.00.

Section 2. This Resolution shall take effect immediately upon adoption.


