

RESOLUTION NO. 04-89

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DORAL ADOPTING, CERTIFYING, AND LEVYING A MILLAGE RATE OF \$2.447 ON TANGIBLE PERSONAL PROPERTY AND ASSESSED REAL PROPERTY LOCATED WITHIN THE MUNICIPAL LIMITS OF THE CITY OF DORAL, FLORIDA FOR FISCAL YEAR 2004-2005; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Doral under the laws of Florida, is authorized to levy ad valorem taxes to support the operation of its local government; and

WHEREAS, pursuant to law, the City has conducted public hearings and workshops in review of its proposed General Fund budget, as well as the proposed millage rate to balance said budget; and

WHEREAS, a budget has been prepared estimating General Fund expenditures of \$33,229,972 and General Fund revenues of \$33,229,972 of the City of Doral, Florida, for the ensuing year, with detailed information, including revenue to be derived from sources other than ad valorem levy, and the City Manager has made a recommendation as to the amount necessary to be appropriated for the ensuing year; and

WHEREAS, pursuant to Chapter 200, Florida Statutes, a method is prescribed for fixing the millage for the purpose of establishing the basis for the collection of said funds; and

WHEREAS, the City Council has simultaneously determined that a \$2.447 mills ad valorem tax on tangible personal property and assessed real property will produce revenues in a total amount of \$15,080,202 to provide for its General Operating Budget.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:

1. That for Fiscal Year 2004-2005, which begins October 1, 2004, and expires on September 30, 2005, there is hereby levied \$2.447 mill tax on all tangible personal property and

assessed real property located within the municipal limits of the City of Doral, Florida, for the General Operating Fund for the City of Doral.

2. That the General Operating Fund \$2.447 millage rate hereby established is not more than the rolled-back rate of \$0.00.
3. If any section, part of section, paragraph, clause, phrase or word of this Resolution is declared invalid, the remaining provisions of this Resolution shall not be affected.
4. This Resolution shall become effective upon adoption.

The foregoing Resolution was offered by Councilman Van Name, who moved its adoption. The motion was seconded by Vice Mayor Cabrera and upon being put to a vote, the vote was as follows:


