meeting with different families and potential students. Their goal is to start with twelve students that have similar needs, so they can serve them the best way they can. He believes that they have identified the group that they'll be working with for occupational and speech therapy.

b. Discussion: Give a Store Non-Profit

Sergio informed the board that he was approached by someone who was looking to start their business on dog grooming and their employees would be people with special needs. Sergio said that it gave him an idea to possibly bring a business like that here to Doral. He stated to the board that they should start thinking about occupation/professionalization after education for special needs students. The best direction would be to bring in someone to present on this specific topic, so that they can answer any question that the board has.

c. Discussion: Planning Initiatives for 2020

Sergio briefly discussed a possible initiative that the board can work with, but more will be discussed at the next meeting.

Vinita discussed that she wants the board to come up with ideas to put together, so that for every meeting that they have, there is an item on the agenda that the board wants to collectively discuss.
