A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE AND RETROFITTING OF THREE (3) NEW POLICE VEHICLES IN AN AMOUNT NOT TO EXCEED \$150,000.00 VIA THE AGREEMENT WITH THE FLORIDA SHERIFF'S ASSOCIATION CONTRACT No. FSA20-VEL 28.0 WITH PALMETTO FORD TRUCK SALES; AUTHORIZING THE CITY MANAGER TO PURCHASE THE VEHICLES FROM THE NEXT LOWEST VENDOR SUCCESSIVELY IF THE VENDOR IS NOT RESPONSIVE OR A PURCHASE AGREEMENT CAN NOT BE NEGOTIATED WITH THE TOP BIDDER; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Public Works Department (PWD) respectfully requests authorization from the Mayor and the City Council-Members to authorize the City Manager to purchase three (3) Ford Police Interceptor Hybrid via the Florida Sheriffs Association Contract FSA 20-VEL28.0; and

WHEREAS, the new police vehicles are to replace three total loss vehicles (Units: 185, 240 and 262); and

WHEREAS, the Hybrid vehicle has a fuel efficiency combined of 24-mpg (Miles per gallon), while the previous Police interceptor was rated at 17-mpg (Miles per gallon) and idle fuel consume of 0.204 gallon per hours comparing with 0.465 gallons per hour on the current model; and

WHEREAS, the Hybrid vehicle will reduce fuel consume on an estimated 40 percent, and will provide for lower emissions (by 34 percent); and

WHEREAS, the PWD recommends that the City Council authorize the City Manager for the purchase of three (3) Ford Police Interceptor Hybrid from the lowest and most responsive bidder, Palmetto Ford Truck Sales via the Florida Sheriffs Contract FSA 20-VEL28.0 in an amount not to exceed \$150,000.00, which was

competitively entered into in a matter similar to that set forth in Chapter 2, Article V of the City Code; and

WHEREAS, funding for this request is available in the current Fiscal Year "Capital Outlay – Vehicles" Account, Account No. 304.50005.500641

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Pursuant to section 2-322, the purchase of three (3) new police vehicles via the Florida Sheriffs Association Contract FSA20-VEL28.0 in an amount not to exceed \$150,000.00 is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution. The City Manager is further authorized to negotiate and enter into a purchase agreement with the next highest ranked vendor successively if an agreement cannot be entered into with lowest bidder successively.

<u>Section 4.</u> <u>Authorization.</u> The City Manager is authorized to execute the title documents of each vehicle in Exhibit "A" and proceed with the auctioning of the vehicles on behalf of the City.
